18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

19 MARYLAND, That the Laws of Maryland read as follows:

3                   (c) (1) An original or substitute commemorative plate may only be issued under  
4 this section for a fixed period of 2 consecutive years after its initial issuance.

5                   (2) The Administration may only issue 1 commemorative plate under this  
6 section at any one time.
