- 6 (1) The right of an individual to practice a health occupation that the

- 8 (2) The right of an individual to provide vocational rehabilitation services as 9 authorized under Title 9, Subtitle 6 of the Labor and Employment Article;

- 17 (a) Except as otherwise provided in this section, an individual shall be licensed by 18 the Board before the individual may practice psychology in this State.
- 19 (b) Subject to the rules and regulations of the Board, this section does not apply 20 to:
- 21 (1) The activities and services of, and the use of an official title by an
- 22 individual employed by any agency of the federal government, this State, or any political
- 23 subdivision of this State, or a chartered educational institution whileperforming the
- 24 duties of that employment;
- 25 (2) The education-related services described in regulations adopted by the
- 26 State Department of Education that are performed by a certified school psychologist:
- 27 (i) While performing the duties of employment of the certified school

2	(c) If, for good cause, an applicant for a license under subsection (b)(5) of this section is unable to take the first scheduled examination for which theapplicant is eligible, the Board may grant an extension to the individual to take the next scheduled examination for which the applicant is eligible.

32 32 34 35	(e) The exceptions of subsection (b)(1) of this section do not applyto individuals who are employed by the Department, a county health department, the Baltimore City Health Department, the Department of State Police, or the Department ofPublic Safety and Correctional Services after July 1, 1985. An individual who is employed by any of the departments under this subsection on July 1, 1985 but who is not licensed by the Board shall function under the direct supervision of a licensed psychologist who takes full responsibility for the psychological services provided by the individual.
