- 17 (A) An individual who assists an executive unit in the drafting of specifications, an
- 18 invitation for bids, or a request for proposals for a procurement, or aperson that employs
- 19 the individual, may not:
- 20 (1) submit a bid or proposal for that procurement; or
- 21 (2) assist or represent another person, directly or indirectly, who is
- 22 submitting a bid or proposal for that procurement.
