3 FOR the purpose of providing that certain kinds of activities do not disqualify an
4 individual from participating in or assisting another in participating in certain
5 procurements; and generally relating to the limitation on participating in a
6 procurement after assisting in the drafting of certain documents relating to that
7 procurement.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

14 MARYLAND, That the Laws of Maryland read as follows:

15 **Article - State Government**

16 15-508.

17 (A) An individual who assists an executive unit in the drafting of specifications, an
18 invitation for bids, or a request for proposals for a procurement, or a person that employs
19 the individual, may not:

20 (1) submit a bid or proposal for that procurement; or

21 (2) assist or represent another person, directly or indirectly, who is
22 submitting a bid or proposal for that procurement.

1 (B) FOR PURPOSES OF SUBSECTION (A) OF THIS SECTION, ASSISTING IN THE
2 DRAFTING OF SPECIFICATIONS, AN INVITATION FOR BIDS, OR A REQUEST FOR
3 PROPOSALS FOR A PROCUREMENT DOES NOT INCLUDE:

4 (1) PROVIDING DESCRIPTIVE LITERATURE SUCH AS CATALOGUE
5 SHEETS, BROCHURES, TECHNICAL DATA SHEETS, OR STANDARD SPECIFICATION
6 "SAMPLES", WHETHER REQUESTED BY AN EXECUTIVE AGENCY OR PROVIDED ON
7 AN UNSOLICITED BASIS;

8 (2) SUBMITTING WRITTEN COMMENTS ON A SPECIFICATION PREPARED
9 BY AN AGENCY OR ON A SOLICITATION FOR A BID OR PROPOSAL WHEN COMMENTS
10 ARE SOLICITED FROM TWO OR MORE ~~INDIVIDUALS~~ PERSONS AS PART OF A
11 REQUEST FOR INFORMATION OR A PREBID OR PREPROPOSAL PROCESS; OR

12 (3) PROVIDING SPECIFICATIONS FOR A SOLE SOURCE PROCUREMENT
13 MADE IN ACCORDANCE WITH § 13-107 OF THE STATE FINANCE AND PROCUREMENT
14 ARTICLE.

15 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
16 July 1, 1996.
