2 Health Insurance - Reconstructive Breast Surgery - Coverage

3 FOR the purpose of requiring that certain insurers, nonprofit health service plans, and

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 17

18 MARYLAND, That the Laws of Maryland read as follows:

19 Article 48A - Insurance Code

(A) (1) IN THIS SECTION, "RECONSTRUCTIVE BREAST SURGERY" MEANS 21 22 SURGERY PERFORMED, FOLLOWING A MASTECTOMY, ON ONE BREAST OR BOTH 23 BREASTS TO REESTABLISH SYMMETRY BETWEEN THE TWO BREASTS.

(2) "RECONSTRUCTIVE BREAST SURGERY" INCLUDES AUGMENTATION 24 25 MAMMOPLASTY, REDUCTION MAMMOPLASTY, AND MASTOPEXY.

26 (B) AN INSURER OR NONPROFIT HEALTH SERVICE PLAN THAT PROVIDES 27 HOSPITAL, MEDICAL, OR SURGICAL BENEFITS FOR ISSUANCE OR DELIVERY IN THE 28 STATE TO ANY GROUP OR INDIVIDUAL ON AN EXPENSE-INCURRED BASIS, 29 INCLUDING A HEALTH MAINTENANCE ORGANIZATION, SHALL PROVIDE COVERAGE 30 FOR RECONSTRUCTIVE BREAST SURGERY.

5 (2) THE PROVISIONS OF ARTICLE 48A, § 490FF OF THE CODE SHALL6 APPLY TO HEALTH MAINTENANCE ORGANIZATIONS.
