11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

15 (a) (1) Except in Montgomery County and except as provided in paragraph (2)

16 of this subsection for BALTIMORE CITY AND Baltimore County and in paragraph (3) of 17 this subsection for St. Mary's County, the clerk of each circuit court shall:

- (i) Collect, in advance, a \$10 fee for docketing the appearance ofcounsel when bringing or defending a civil action in the court;
- 20 (ii) Charge as costs a \$10 fee for docketing the appearance of counsel 21 when prosecuting or defending a criminal action in the court; and
- (iii) Collect, in advance, a \$10 fee for docketing the appearance ofcounsel when bringing or defending a case in the Court of Appeals.
