- 25 MARYLAND, That the Laws of Maryland read as follows:

(F) NOTWITHSTANDING THE PROVISIONS OF § 16-202(A)(2) OF THIS SUBTITLE, 16 17 THE BOARD OF TRUSTEES MAY CHOOSE THE CHANCELLOR TO SERVE AS 18 SECRETARY-TREASURER OF THE BOARD. 19 (G) NOTWITHSTANDING THE PROVISIONS OF § 16-203(F)(2) OF THIS SUBTITLE, 20 THE CHANCELLOR MAY EXECUTE A CONVEYANCE OR OTHER LEGAL DOCUMENT 21 UNDER AN APPROPRIATE RESOLUTION OF THE BOARD OF TRUSTEES. 22 (H) NOTWITHSTANDING THE PROVISIONS OF § 16-203(M) OF THIS SUBTITLE, 23 THE BOARD OF TRUSTEES SHALL BE STYLED "THE BOARD OF TRUSTEES OF THE 24 COMMUNITY COLLEGES OF BALTIMORE COUNTY".
