CHAPTER ____

1 AN ACT concerning

2 Community Colleges of Baltimore County - Board of Trustees - Chancellor

3 FOR the purpose of allowing the Chancellor of the Community Colleges of Baltimore
4 County to serve in a certain capacity on the Board of Trustees of the Community
5 Colleges of Baltimore County; allowing the Chancellor to execute certain
6 documents under certain circumstances; altering the style for the name of the Board
7 of Trustees; and generally relating to the Chancellor and the Board of Trustees of
8 the Community Colleges of Baltimore County.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
2 MARYLAND, That the Laws of Maryland read as follows:

3 **Article - Education**

4 16-202.

5 (a) Each board of trustees:

6 (1) Shall elect one of its members as its chairman;

7 (2) [Shall] EXCEPT AS PROVIDED IN § 16-204.1(F) OF THIS SUBTITLE,
8 SHALL choose the president of one of the county community colleges to serve as
9 secretary-treasurer of the board; and

10 (3) May elect any other officer it requires.

12 (f) (2) [The] EXCEPT AS PROVIDED IN § 16-204.1(G) OF THIS SUBTITLE, THE
13 president of the community college and the chairman of the board of trustees may
14 execute a conveyance or other legal document under an appropriate resolution of the
15 board.

16 (m) [Each] EXCEPT AS PROVIDED IN § 16-204.1(H) OF THIS SUBTITLE, EACH
17 board of trustees shall be styled "the board of trustees of community (or
18 junior) college".

20 (b) The Board of Trustees for Baltimore County shall appoint a Chancellor of the
21 community colleges in Baltimore County who shall serve at the pleasure of the Board.

22 (F) NOTWITHSTANDING THE PROVISIONS OF § 16-202(A)(2) OF THIS SUBTITLE,
23 THE BOARD OF TRUSTEES MAY CHOOSE THE CHANCELLOR TO SERVE AS
24 SECRETARY-TREASURER OF THE BOARD.

25 (G) NOTWITHSTANDING THE PROVISIONS OF § 16-203(F)(2) OF THIS SUBTITLE,
26 THE CHANCELLOR MAY EXECUTE A CONVEYANCE OR OTHER LEGAL DOCUMENT
27 UNDER AN APPROPRIATE RESOLUTION OF THE BOARD OF TRUSTEES.

28 (H) NOTWITHSTANDING THE PROVISIONS OF § 16-203(M) OF THIS SUBTITLE,
29 THE BOARD OF TRUSTEES SHALL BE STYLED "THE BOARD OF TRUSTEES OF THE
30 COMMUNITY COLLEGES OF BALTIMORE COUNTY".

31 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
32 October 1, 1996.
