7	(a) (1) The Board consists of 25 members.
8	(2) Of the 25 Board members:
9	(i) [8] EIGHT shall be public school classroom teachers, as follows:
	1. [6] SIX shall be chosen from a list of nominees provided by the statewide teachers' organization representing a majority of teachers in the State for collective bargaining purposes; and
15	2. [2] TWO shall be chosen from a list of nominees provided by a statewide teachers' organization representing teachers in at least one jurisdiction within the State for collective bargaining purposes other than the majority organization provided for in item 1 of this subparagraph;
17 18	(ii) [1] ONE shall be a certified nonpublic school classroom teacher, chosen from a list of nominees provided by the Association of Independent Schools;
19 20	(iii) [6] SIX shall be teacher education faculty members from colleges of the State, chosen from a list of nominees provided by:
21	1. The Maryland Association of Teacher Educators; and
22	2. The Maryland Association of Colleges of Teacher Education:
23 24	(iv) [4] FOUR shall be administrative or supervisory staffmembers of public schools, as follows:
25 26	1. [2] TWO shall be chosen from a list of nominees provided by the Public School Superintendents' Association of Maryland;
27 28	2. [1] ONE shall be chosen from a list of nominees provided by the Maryland Association of Secondary Principals; and
29 30	3. [1] ONE shall be chosen from a list of nominees provided by the Maryland Association of Elementary School Administrators;
33	(v) [2] TWO shall be [administrative or supervisory staff of the approved nonpublic schools of the State,] chosen from [a list of nominees provided by the Association of Independent Schools] THE MEMBERS OF THE MARYLAND STATE BOARD OF EDUCATION;
35 36	(vi) [1] ONE shall be a member of a local board of education, chosen from a list of nominees provided by the Maryland Association of Boards of Education;

1	(vii) [2] TWO shall be representatives of the general public, as follows:
2	1. [1] ONE shall be chosen from a list of nominees provided by the Speaker of the House of Delegates of Maryland; and
4 5	2. [1] ONE shall be chosen from a list of nominees provided by the President of the Senate of Maryland; and
6 7	(viii) [1] ONE shall be the State Superintendent or a designee of the State Superintendent.
8 9	(3) The Board shall include all the members of the ProfessionalStandards and Teacher Education Advisory Board serving on July 1, 1991.
	(b) (1) The Governor, with the advice and consent of the Senate of Maryland, shall appoint the members of the Board described in subsection (a)(2)(i) through (vii) of this section.
13 14	(2) In making the appointments required under this subsection, the Governor shall ensure that the Board is representative of:
15	(i) The geographic regions of the State; and
16 17	(ii) Minority populations of the State as defined in § 9-301 of the State Government Article.
18	(c) (1) The term of an appointed member is 3 years.
19 20	(2) The terms of the appointed members are staggered as required by the terms provided for members of the Board on October 1, 1991.
21 22	(3) At the end of a term, a member continues to serve until a successor is appointed.
23 24	(4) A member who is appointed after a term has begun serves only for the remainder of the term and until a successor is appointed and qualifies.
25	(d) The Governor may remove a member for incompetence or misconduct.
26	(e) From among its members, the Board annually shall elect a chairman.
27 28	(f) A majority of the members of the Board then serving on the Boardis a quorum.
29	(g) The staff for the Board shall be provided by the State Board.

33	(a) (1) In accordance with Title 10, Subtitle 1 of the State Government Article, [both the State Board and] the Board shall [develop for consideration] ADOPT rules and regulations CONSISTENT WITH THE GOALS OF THE STATE BOARD OF EDUCATION for:

	[(8)] (2) An individual who is otherwise qualified may not be denied the right to receive credentials from the Board, to receive training to become a teacher, or to practice teaching in any school because that individual is totally or partially blind.
	[(9)] (3) A county board may not refuse to contract with or engage a teacher because of blindness if the blind teacher is capable of performing the duties of the position for which he has applied.
26	[(10)] (4) The right of a school psychologist, who is certified by the Board to practice school psychology consistent with the provisions of that certification, may not be limited by Title 18 of the Health Occupations Article with respect to the practice of school psychology in an educational institution.

31 32	EXCEPT FOR A REQUIREMENT FOR A TEACHER CERTIFICATION TEST, THE STATE SUPERINTENDENT HAS THE AUTHORITY TO WAIVE SPECIFIC REQUIREMENTS FOR A CERTIFICATE IN AN INDIVIDUAL CASE, IF THE STATE SUPERINTENDENT DETERMINES, AFTER THOROUGH INVESTIGATION, THAT THE APPLICANT'S PREPARATION OR EXPERTISE, OR BOTH, ARE ADEQUATE TO JUSTIFY A WAIVER.
