- 23 (c) The Board shall publish in its rules and regulations the fees that it sets.

	(ii) Any unspent portions of the BOARD OF NURSING Fund maynot be transferred or revert to the General Fund of the State, but shall remain in the BOARD OF NURSING Fund to be used for the purposes specified in this title.
