- 24 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 25 MARYLAND, That the Laws of Maryland read as follows:

1 **Article - Health Occupations** 2 [12-305. 3 (a) Subject to the provisions of this section, the Board may make a reciprocal 4 agreement with any other state to waive any examination requirement of this title for an 5 individual who is licensed to practice pharmacy in that state. 6 (b) An agreement made under this section may allow the Board to grant a waiver 7 only if the individual: 8 (1) Is of good moral character; 9 (2) Pays the application fee set by the Board; and 10 (3) Provides adequate evidence that: (i) At the time the applicant was licensed in the other state, the 11 12 applicant was qualified to take the examination that then was required by the laws of this 13 State: and 14 (ii) The applicant qualified for a license in the other state by passing 15 an examination administered in that or any other state. 16 (c) An agreement may be made with another state under this section only if, 17 under the agreement, the other state waives the examination of licensees of this State to 18 a similar extent as this State waives the examination requirements for individuals licensed 19 in that state.] 20 12-305. (A) SUBJECT TO THE PROVISIONS OF THIS SECTION, THE BOARD MAY WAIVE 2.1 22 ANY EXAMINATION REQUIREMENT OF THIS TITLE FOR AN APPLICANT WHO IS 23 LICENSED TO PRACTICE PHARMACY IN ANY OTHER STATE, IF THAT STATE GRANTS 24 A SIMILAR WAIVER TO LICENSEES OF THIS STATE. 25 (B) THE BOARD MAY GRANT A WAIVER UNDER THIS SECTION ONLY IF THE 26 APPLICANT: 27 (1) IS OF GOOD MORAL CHARACTER; 28 (2) PAYS THE APPLICATION FEE SET BY THE BOARD; AND 29 (3) PROVIDES ADEQUATE EVIDENCE THAT THE APPLICANT: 30 (I) MEETS THE QUALIFICATIONS OTHERWISE REQUIRED BY THIS 31 TITLE: AND 32 (II) BECAME LICENSED OR REGISTERED IN THE OTHER STATE TO 33 PRACTICE PHARMACY ONLY AFTER PASSING AN EXAMINATION THAT IS APPROVED 34 BY THE BOARD.

35 (C) THE BOARD SHALL ADOPT BY REGULATION AN EXAMINATION TO BE 36 ADMINISTERED TO APPLICANTS WHO ARE LICENSED TO PRACTICE PHARMACY IN 37 ANY OTHER STATE. 3

AND BE IT FURTHER ENACTED, That the State Board of Pharmacy shall adopt and publish regulations to govern the transition to the new expiration date for licenses to be set by the Board. These regulations shall provide for continuing education requirements and the assessment of license renewalfees that take into account the period between the former expiration date of September30 and the new expiration date to be set by the Board. The license renewal fees and continuing education requirements shall be consistent with the fee schedules and continuing education requirements for license renewal as otherwise provided under the Maryland Pharmacy Act and the regulations of the Board. |

SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
