2 Garrett County Board of Education - Student Member

- 3 FOR the purpose of adding a nonvoting student member to the Garrett County Board of Education; specifying certain qualifications and requirements concerning the 4 student member position; establishing certain procedures regarding the selection of 5 6 the student member and an alternate; requiring the Garrett County Association of 7 Student Councils to propose, and the elected members of the Garrett County Board 8 of Education to approve, certain procedures; specifying the type of meetings the 9 student member may attend; limiting eligibility for the positions ofpresident and vice-president of the Board to elected members; defining "elected member"; 10 11
- making stylistic changes; providing for the application of this Act;and generally relating to the membership of the Board of Education of Garrett County.

- 23 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 24 MARYLAND, That the Laws of Maryland read as follows:

	(a) (1) IN THIS SUBTITLE, "ELECTED MEMBER" MEANS A MEMBER OF THE COUNTY BOARD ELECTED UNDER SUBSECTION (B)(1) OR (2) OF THIS SECTION OR APPOINTED TO FILL A VACANCY UNDER SUBSECTION (E)(3) OF THIS SECTION.
6	(2) "ELECTED MEMBER" DOES NOT INCLUDE:
7 8	(I) THE CHAIRMAN OR VICE CHAIRMAN OF THE BOARD OF COUNTY COMMISSIONERS; OR

17 18	[(b)] (C) (1) A candidate from a County commissioner district shall be a resident of that district.
19	(2) The member from the County at large shall be a resident of the County.
20 21	(3) A candidate for the County Board shall be a registered voter of the County.
22 23	(4) (i) A member from a County commissioner district who no longer resides in that district may not continue as a member of the County Board.
24 25	(ii) A member at large who no longer resides in the Countymay not continue as a member of the County Board.
26 27	[(c)] (D) (1) [Members] ELECTED MEMBERS of the Board shall be elected at a general election as required by subsection [(d)] (E) of this section.
28 29	(2) THE STUDENT MEMBER SHALL BE SELECTED IN ACCORDANCE WITH SUBSECTION (F) OF THIS SECTION.
	[(d)] (E) (1) [Except for the Chairman or Vice Chairman of the County Commissioners, each] EACH ELECTED member serves for a term of 4 years beginning on January 1 after the member's election and until a successor is elected and qualifies.
33	(2) The terms FOR ELECTED MEMBERS are staggered as required by the

34 terms of the members serving on January 1, 1985.

	(3) The County Commissioners shall appoint a qualified individual to fill any vacancy IN AN ELECTED MEMBER'S POSITION on the Board for the remainder of the term and until a successor is elected and qualifies.
6	(F) (1) EACH MAY, THE ELECTED MEMBERS OF THE COUNTY BOARD SHALL SELECT A STUDENT MEMBER, AND AN ALTERNATE TO SERVE IN THE EVENT OF A VACANCY IN THE STUDENT MEMBER'S POSITION, FROM AMONG CANDIDATES RECOMMENDED BY THE GARRETT COUNTY ASSOCIATION OF STUDENT COUNCILS.
8 9	(2) THE TERM OF THE STUDENT MEMBER IS 1 YEAR AND BEGINS ON JULY 1.
10 11	(3) TO BE CONSIDERED FOR THE POSITION OF STUDENT MEMBER, OR AS THE ALTERNATE FOR THE STUDENT MEMBER'S POSITION, A STUDENT SHALL:
12 13	(I) BE A SOPHOMORE OR JUNIOR IN HIGH SCHOOL AT THE TIME OF APPLYING;
14 15	(II) HAVE ATTENDED GARRETT COUNTY PUBLIC SCHOOLS FOR AT LEAST 2 YEARS;
	(III) BE IN GOOD ACADEMIC STANDING AND HAVE MAINTAINED A GRADE AVERAGE OF AT LEAST 80% DURING THE PREVIOUS 2 ACADEMIC YEARS; AND
19 20	(IV) NOT HAVE EXPERIENCED SIGNIFICANT ATTENDANCE OR DISCIPLINARY PROBLEMS DURING THE STUDENT'S HIGH SCHOOL CAREER.
	(4) (I) THE GARRETT COUNTY ASSOCIATION OF STUDENT COUNCILS SHALL PROPOSE PROCEDURES GOVERNING THE SELECTION OF CANDIDATES FOR THE STUDENT MEMBER'S POSITION.
24 25	(II) THE PROCEDURES PROPOSED UNDER THIS PARAGRAPH ARE SUBJECT TO THE APPROVAL BY THE ELECTED MEMBERS OF THE BOARD.
28 29 30	(III) THE PROCEDURES ADOPTED UNDER THIS PARAGRAPH SHALL PROVIDE FOR THE SELECTION OF UP TO FOUR CANDIDATES, SELECTED BY THE GARRETT COUNTY ASSOCIATION OF STUDENT COUNCILS BY SECRET BALLOT, FOR THE POSITION OF STUDENT MEMBER. THE NAMES OF THE CANDIDATES SHALL BE FORWARDED TO THE ELECTED MEMBERS OF THE COUNTY BOARD FOR FINAL SELECTION OF THE STUDENT MEMBER AND OF AN ALTERNATE.

	[(e)] (G) (1) The State Board may remove [a] AN ELECTED member of the County Board [, except the Chairman or Vice Chairman of the Board of County Commissioners,] for:
8	(i) Immorality;
9	(ii) Misconduct in office;
10	(iii) Incompetency; or
11	(iv) Willful neglect of duty.
	(2) Before removing a member, the State Board shall send the member a copy of the charges [against him] and give [him] THE MEMBER an opportunity within 10 days to request a hearing.
15	(3) If the member requests a hearing within the 10-day period:
	(i) The State Board promptly shall hold a hearing, but a hearing may not be set within 10 days after the State Board sends the member a notice of the hearing; and
19 20	(ii) The member shall have an opportunity to be heard publicly before the State Board in his own defense, in person or by counsel.
21 22	(4) A member removed under this subsection has the right to a de novo review of the removal by the Circuit Court for Garrett County.

24 25	At its first meeting at the beginning of each year, the County Boardshall elect a president and a vice-president from among its ELECTED members.

27 28	[Except for the Chairman or Vice Chairman of the County Commissioners, each] EACH ELECTED member of the County Board is entitled to:
29 30	(1) The salary set by the County Commissioners in accordance with Chapter 91 of the Public Local Laws of Garrett County; and
	(2) Reimbursement not exceeding \$400 a year for travel and other expenses, including travel expenses to and from board meetings held in the countyat the rate Garrett County pays for mileage.

35	(a) All final actions of the County Board shall be taken at a publicmeeting. The

36 Board shall keep a formal record of each public meeting.

- 1 (b) This section does not prohibit the Board from meeting and deliberating in 2 executive session provided that all action is taken at a public meeting.
- 3 SECTION 2. AND BE IT FURTHER ENACTED, That, notwithstanding the
- 4 effective date of this Act, a nonvoting student member selected during the 1995-1996
- 5 school year in accordance with procedures similar to § 3-4A-01(f) of the Education
- 6 Article, as enacted by Section 1 of this Act, may serve on the Garrett County Board of
- 7 Education for the period beginning July 1, 1996.
- 8 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 9 July 1, 1996.
