2 Pistols and Revolvers - Straw Transactions - Prohibition

- 3 FOR the purpose of prohibiting a person from selling, buying, transferring, accepting
- 4 delivery of, or attempting or conspiring to sell, buy, transfer, or accept delivery of a
- 5 pistol or revolver through a straw transaction; defining a certain term; and generally
- 6 relating to the straw transactions of pistols and revolvers.

- 12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 13 MARYLAND, That the Laws of Maryland read as follows:
- 14 Article 27 Crimes and Punishments
- 15 445.
- 16 (D) (1) IN THIS SUBSECTION, "STRAW TRANSACTION" MEANS THE SALE OR
- 17 DELIVERY OF A PISTOL OR REVOLVER BY A LICENSED FIREARMS DEALER TO A
- 18 PERSON WHO IS ACTING AS AN AGENT OR INTERMEDIARY FOR ANOTHER WHOM
- 19 THE PERSON KNOWS OR HAS REASON TO KNOW IS INELIGIBLE UNDER FEDERAL OR
- 20 STATE LAW TO PURCHASE A FIREARM DIRECTLY FROM THE DEALER.
- 21 (2) A PERSON MAY NOT KNOWINGLY SELL, BUY, TRANSFER, ACCEPT
- 22 DELIVERY OF, OR ATTEMPT OR CONSPIRE TO SELL, BUY, TRANSFER, OR ACCEPT
- 23 DELIVERY OF A PISTOL OR REVOLVER THROUGH A STRAW TRANSACTION.
- 24 (3) THIS SUBSECTION DOES NOT APPLY TO PERSONS WHO PURCHASE A
- 25 PISTOL OR REVOLVER WITH THE INTENT OF MAKING A BONA FIDE GIFT OF THE
- 26 PISTOL OR REVOLVER TO ANOTHER.
- 27 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 28 October 1, 1996.
