- 18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

19 MARYLAND, That the Laws of Maryland read as follows:

- 20 Article 2B Alcoholic Beverages
- 21 7-101.
- 22 (b) (2) In Anne Arundel County the fee is [\$10] \$20 per day.
- 23 (d) (2) In Anne Arundel County:
- 24 (i) A special beer, wine and liquor license, Class C licensee may25 purchase beer from a wholesaler.
- 26 (ii) The fee is [\$25] \$50 per day.

2 (Q) (1) THIS SUBSECTION APPLIES ONLY IN ANNE ARUNDEL COUNTY.

3 (2) BETWEEN MARCH 1 AND MARCH 31, INCLUSIVE, EACH YEAR, A4 LICENSEE SHALL FILE AN APPLICATION FOR LICENSE RENEWAL WITH THE BOARD.

5 (3) A LICENSE RENEWAL APPLICATION RECEIVED BY THE BOARD6 AFTER MARCH 31 MAY BE SUBJECT TO:

7 (I) REJECTION; OR

8 (II) A LATE CHARGE OF \$250, PLUS A DAY CHARGE OF \$50 FOR
9 EACH DAY THE APPLICATION IS FILED LATE. THE TOTAL AMOUNT MAY NOT
10 EXCEED \$1,500.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
 October 1, 1996.
