1 AN ACT concerning

2 **Public Information - Reasonable Fee Guarantee**

3 FOR the purpose of altering provisions of law relating to the fee that may be imposed by
4 a unit of State or local government for reproducing a public record; superseding,
5 under certain circumstances, provisions of law that set a specific fee; repealing the
6 statutory fee for obtaining copies of documents on file with the Office of the
7 Insurance Commissioner; providing for the future codification of certain provisions
8 of this Act; and generally relating to access to public records.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

15 MARYLAND, That the Laws of Maryland read as follows:

16 **Article 48A - Insurance Code**

18 The Commissioner shall collect in advance, and the persons so served shall pay the
19 following fees to the Commissioner:

22 **Article - State Government**

24 (a) (1) Subject to the limitations in this section, the official custodian may
25 charge an applicant a reasonable fee for the search for, preparation of, and reproduction
26 of a public record.

27 (2) THE FEE FOR REPRODUCTION OF A PUBLIC RECORD, ~~SHALL BE~~ MAY
28 NOT BE MORE THAN THE ACTUAL COST OF REPRODUCTION.

29 (b) The official custodian may not charge a fee for the first 2 hours that are
30 needed to search for a public record and prepare it for inspection.

31 (c) (1) [If] SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION, IF another
32 law sets a fee for a copy, printout, or photograph of a public record, that law applies.

33 (2) NOTWITHSTANDING ANY OTHER PROVISION OF LAW, AS TO
34 REPRODUCTION OF A PUBLIC RECORD MADE DURING THE 2-HOUR PERIOD
35 REFERRED TO IN SUBSECTION (B) OF THIS SECTION THE CUSTODIAN MAY CHARGE
36 A FEE OF NOT MORE THAN THE ACTUAL COST OF REPRODUCTION.

1 [(2)] (3) The official custodian otherwise may charge any reasonable fee for
2 making or supervising the making of a copy, printout, or photograph of a public record.

3 [(3)] (4) The official custodian may charge for the cost of providing
4 facilities for the reproduction of the public record if the custodian did not have the
5 facilities.

6 (d) The official custodian may waive a fee under this section if:

7 (1) the applicant asks for a waiver; and

8 (2) after consideration of the ability of the applicant to pay the fee and
9 other relevant factors, the official custodian determines that the waiver would be in the
10 public interest.

11 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland
12 read as follows:

13 **Article - Insurance**

14 2-112.

15 (a) Fees for the following certificates, licenses, and services shall be collected in
16 advance by the Commissioner, and shall be paid by the appropriate persons to the
17 Commissioner:

20 SECTION 3. AND BE IT FURTHER ENACTED, That Section(s) 41(17) through
21 (21), respectively, of Article 48A - Insurance Code of the Annotated Code of Maryland
22 be renumbered to be Section(s) 41(16) through (20), respectively.

23 SECTION 4. AND BE IT FURTHER ENACTED, That Section(s) 2-112(a)(17),
24 (18), and (19), respectively, of Article - Insurance Code of the Annotated Code of
25 Maryland be renumbered to be Section(s) 2-112(a)(16), (17), and (18), respectively.

26 SECTION 5. AND BE IT FURTHER ENACTED, That Sections 1 and 3 of this
27 Act shall take effect October 1, 1996.

28 SECTION 6. AND BE IT FURTHER ENACTED, That Sections 2 and 4 this Act
29 shall take effect October 1, 1997.
