18	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
19	MARYLAND, That the Laws of Maryland read as follows:
20	Article 2B - Alcoholic Beverages

- (a) (7) IN GARRETT COUNTY, SUNDAY SALES ARE GOVERNED BY $\S~11\text{-}512$ 22
- 23 OF THIS ARTICLE.
- (b) (5) (I) THIS PARAGRAPH APPLIES ONLY IN [In] Garrett County[, 24
- 25 however, Sunday sales when].
- (II) WHEN New Year's Eve or New Year's Day fall on a Sunday, SALES 26
- 27 shall be governed by § 11-402(j) of this article.
- (III) PROVISIONS FOR SUNDAY SALES FOR CLASS B AND C
- 29 LICENSEES ARE GOVERNED BY § 11-512 OF THIS ARTICLE.

- 2 (A) [In] THIS SECTION APPLIES ONLY IN Garrett County[, notwithstanding].
- 3 (B) (1) NOTWITHSTANDING any other provisions of this subtitle and except on
- 4 Sundays and New Year's Day, holders of any class of on- or off-sale licenses issued under
- 5 this article[, including a holder of a Class E steamboat license issuedby the State
- 6 Comptroller's Office for use on all State waters located within GarrettCounty,] may sell
- 7 the alcoholic beverages authorized under their respective license from 6 a.m. to 2 a.m. the
- 8 following day, but may not sell alcoholic beverages between the hours of 2 a.m. and 6 a.m.
- 9 on any day of the week or, UNLESS AUTHORIZED UNDER SUBSECTION (C) OF THIS
- 10 SECTION, at any time on Sunday after 2 a.m.
- 11 (2) THE PROVISIONS OF THIS SUBSECTION APPLY TO A HOLDER OF A
- 12 CLASS E STEAMBOAT LICENSE ISSUED BY THE STATE COMPTROLLER'S OFFICE FOR
- 13 USE ON ALL STATE WATERS LOCATED WITHIN THE COUNTY.
- 14 (3) However, this section is subject to the provisions of § 11-402(j) of this
- 15 article regarding sales on New Year's Eve or New Year's Day regardless of the day of the
- 16 week on which December 31 and January 1 fall.
- 17 (C) (1) THE PROVISIONS OF THIS SUBSECTION APPLY ONLY IN THOSE
- 18 ELECTION DISTRICTS WHICH AUTHORIZE THEM.
- 19 (2) THIS SUBSECTION ONLY APPLIES TO ON-PREMISES SALES BY
- 20 HOLDERS OF CLASS C SERVICE CLUB LICENSES AND, SUBJECT TO PARAGRAPH (4) OF
- 21 THIS SUBSECTION, HOLDERS OF CLASS B LICENSES.
- 22 (3) SUNDAY SALES MAY BEGIN, WHERE PERMITTED, AT 1 P.M. AND
- 23 CONTINUE UNTIL 10 P.M.
- 24 (4) (I) THIS PARAGRAPH DOES NOT APPLY TO A HOLDER OF A CLASS
- 25 C SERVICE CLUB LICENSE.
- 26 (II) SUNDAY SALES MAY BE MADE ONLY WHEN THE CONSUMER
- 27 PLACES AN ORDER FOR A MEAL SIMULTANEOUSLY OR PRIOR TO PLACING AN
- 28 ORDER FOR AN ALCOHOLIC BEVERAGE OR THE CONSUMER IS OTHERWISE
- 29 ENTITLED TO A MEAL ON THE PREMISES AS PART OF A PREARRANGED EVENT, SUCH
- 30 AS A BANQUET, WHERE THE ALCOHOLIC BEVERAGE IS SERVED. BAR OR COUNTER
- 31 SALES MAY BE MADE AS LONG AS THE CONSUMER COMPLIES WITH THE
- 32 REQUIREMENT OF THIS PARAGRAPH.
- 33 SECTION 2. AND BE IT FURTHER ENACTED, That before this Act becomes
- 34 effective it shall first be submitted to a referendum of the legally qualified voters of each
- 35 election district in Garrett County at the general election to be held in November, 1996.
- 36 The Board of County Commissioners and the Board of Supervisors of Elections of
- 37 Garrett County shall do those things necessary and proper to provide for and hold the
- 38 referendum required by this section. If a majority of the votes cast ineach election district
- 39 on the question are "For the referred law" the provisions of this Act shall become
- 40 effective in those election districts on December 14, 1996, but if a majority of the votes
- 41 cast in a particular election district on the question are "Against thereferred law" the
- 42 provisions of this Act are of no effect and null and void in that election district.

- SECTION 3. AND BE IT FURTHER ENACTED, That, subject to the provisions
- 2 of Section 2 of this Act and for the sole purpose of providing for the referendum required
- 3 by Section 2, this Act shall take effect July 1, 1996.
