1 AN ACT concerning

2 Nurse Psychotherapists - Authority to Prescribe and Dispense Drugs

- 3 FOR the purpose of authorizing nurse psychotherapists to prescribe certain drugs and to 4 prepare and dispense samples or starter dosages of certain drugs under certain
- 5 circumstances; requiring nurse psychotherapists to designate certainhealth care
- 6 practitioners under certain circumstances; requiring nurse psychotherapists who
- 7 prepare and dispense drugs to comply with certain requirements; prohibiting nurse
- 8 psychotherapists from engaging in certain activities; requiring the State Board of
- 9 Nursing to adopt certain regulations jointly with the State Board of Physician
- 10 Quality Assurance; defining certain terms; and generally relating to the authority of
- 11 nurse psychotherapists to prescribe and dispense drugs under specified

- 18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 19 MARYLAND, That the Laws of Maryland read as follows:

- 22 (A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS
- 23 INDICATED.
- 24 (2) "NURSE PSYCHOTHERAPIST" MEANS A REGISTERED NURSE WHO IS:
- 25 (I) CERTIFIED BY THE BOARD AS A NURSE PSYCHOTHERAPIST;
- 26 AND
- 27 (II) GOVERNED BY REGULATIONS ADOPTED BY THE BOARD
- 28 UNDER § 8-205(A)(4) OF THIS TITLE.
- 29 (3) "PERSONALLY PREPARE AND DISPENSE" MEANS THAT A NURSE
- 30 PSYCHOTHERAPIST:

1	(I) IS PHYSICALLY PRESENT ON THE PREMISES WHERE THE PRESCRIPTION IS FILLED; AND
3 4	(II) PERFORMS A FINAL CHECK OF THE PRESCRIPTION BEFORE IT IS PROVIDED TO THE PATIENT.
5	(4) "PRACTICE NURSE PSYCHOTHERAPY" MEANS TO INDEPENDENTLY:
6	(I) ESTABLISH A MENTAL HEALTH DIAGNOSIS;
7	(II) PROVIDE INDIVIDUAL THERAPY;
8	(III) PROVIDE GROUP THERAPY;
9	(IV) PROVIDE FAMILY THERAPY; OR
10	(V) PROVIDE ANY THERAPY WHOSE PURPOSE IS TO:

18	(5) "PRACTICE NURSE PSYCHOTHERAPY" INCLUDES THE PRESCRIBING OF DRUGS COMMONLY USED IN THE PRACTICE OF NURSE PSYCHOTHERAPY, IF THE NURSE PSYCHOTHERAPIST HAS BEEN APPROVED BY THE BOARD TO PRESCRIBE DRUGS.
20 21	(6) "STARTER DOSAGE" MEANS AN AMOUNT OF DRUG SUFFICIENT TO BEGIN THERAPY:
22	(I) OF SHORT DURATION OF 72 HOURS OR LESS; OR
23 24	(II) PRIOR TO OBTAINING A LARGER QUANTITY OF THE DRUG TO COMPLETE THERAPY.
25 26	(B) (1) A NURSE PSYCHOTHERAPIST MAY PRESCRIBE DRUGS COMMONLY USED IN THE PRACTICE OF NURSE PSYCHOTHERAPY.
29 30 31	(2) BEFORE A NURSE PSYCHOTHERAPIST MAY PRESCRIBE DRUGS COMMONLY USED IN THE PRACTICE OF NURSE PSYCHOTHERAPY, THE NURSE SHALL DESIGNATE A HEALTH CARE PRACTITIONER WHO IS AUTHORIZED TO PRESCRIBE DRUGS UNDER THIS ARTICLE WHO SHALL BE AVAILABLE IN PERSON, BY TELEPHONE, OR BY SOME OTHER MEANS OF COMMUNICATION TO CONSULT WITH THE NURSE SPECIFIC TO THE PRESCRIPTIVE PRACTICE OF THE NURSE.

1	(II) DESCRIBE THE QUALIFICATIONS OF THE HEALTH CARE PRACTITIONER; AND
3	(III) PROVIDE ANY OTHER INFORMATION DEEMED NECESSARY BY THE BOARD.
	(C) A NURSE PSYCHOTHERAPIST MAY PERSONALLY PREPARE AND DISPENSE A SAMPLE OR STARTER DOSAGE OF ANY DRUG THE NURSE PSYCHOTHERAPIST IS AUTHORIZED TO PRESCRIBE TO A PATIENT OF THE NURSE IF:
8 9	(1) FOR A STARTER DOSAGE, THE STARTER DOSAGE COMPLIES WITH THE LABELING REQUIREMENTS OF § 12-509 OF THIS ARTICLE;
10	(2) NO CHARGE IS MADE FOR THE SAMPLE OR STARTER DOSAGE; AND
11 12	(3) THE NURSE PSYCHOTHERAPIST ENTERS AN APPROPRIATE RECORD OF THE SAMPLE OR STARTER DOSAGE IN THE MEDICAL RECORD OF THE PATIENT.
15 16	(D) A NURSE PSYCHOTHERAPIST WHO PERSONALLY PREPARES AND DISPENSES DRUGS IN THE COURSE OF TREATING A PATIENT AS AUTHORIZED UNDER SUBSECTION (C) OF THIS SECTION SHALL ALLOW THE DIVISION OF DRUG CONTROL TO ENTER AND INSPECT THE NURSE PSYCHOTHERAPIST'S OFFICE AT ALL REASONABLE HOURS.
18	(E) A NURSE PSYCHOTHERAPIST MAY NOT:
19	(1) DIRECT A PATIENT TO A SPECIFIC PHARMACY; OR
20 21	(2) RECEIVE REMUNERATION FOR REFERRING PATIENTS TO A SPECIFIC PHARMACY.
	(F) THE BOARD SHALL ADOPT REGULATIONS JOINTLY WITH THE STATE BOARD OF PHYSICIAN QUALITY ASSURANCE TO IMPLEMENT THE PROVISIONS OF SUBSECTION (B) OF THIS SECTION.
