- 21 (a) As used in this article the following terms shall have the meanings indicated
- 22 unless a contrary meaning is clearly intended from the context in whichthe term appears:
- 23 (5) (i) "Contribution" means the gift, transfer or promise of gift or
- 24 transfer of money or other thing of value to any candidate, or the candidate's
- 25 representative, or a representative of any political party or partisan organization to
- 26 promote or assist in the promotion of the success or defeat of any candidate, political
- 27 party, principle or proposition submitted to a vote at any election.

- 2 (H) A PERSON WHO MAKES A CONTRIBUTION, EITHER DIRECTLY OR
- 3 INDIRECTLY, IS NOT ELIGIBLE TO RECEIVE FROM THE STATE ANY FORM OF LICENSE
- 4 OR PERMIT TO CONDUCT CASINO GAMING FOR A PERIOD OF 3 YEARS FROM THE
