## A BILL ENTITLED

1 AN ACT concerning

## 2 Creation of a State Debt - Harford County - Highland Commons

- 3 FOR the purpose of authorizing the creation of a State Debt in the amount of \$175,000,
- 4 the proceeds to be used as a grant to the County Government of Harford County for
- 5 certain acquisition, development, or improvement purposes; providing for
- 6 disbursement of the loan proceeds; and providing generally for the issuance and
- 7 sale of bonds evidencing the loan.
- 8 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 9 MARYLAND, That:
- 10 (1) The Board of Public Works may borrow money and incur indebtedness on
- 11 behalf of the State of Maryland through a State loan to be known as the Harford County
- 12 Highland Commons Loan of 1996 in the total principal amount of \$175,000. This loan
- 13 shall be evidenced by the issuance, sale, and delivery of State generalobligation bonds
- 14 authorized by a resolution of the Board of Public Works and issued, sold, and delivered in
- 15 accordance with §§ 8-117 through 8-124 of the State Finance and Procurement Article
- 16 and Article 31, § 22 of the Code.
- 17 (2) The bonds to evidence this loan or installments of this loan maybe sold as a
- 18 single issue or may be consolidated and sold as part of a single issue of bonds under §
- 19 8-122 of the State Finance and Procurement Article.
- 20 (3) The cash proceeds of the sale of the bonds shall be paid to the Treasurer and
- 21 first shall be applied to the payment of the expenses of issuing, selling, and delivering the
- 22 bonds, unless funds for this purpose are otherwise provided, and then shall be credited on
- 23 the books of the Comptroller and expended, on approval by the Board of Public Works,
- 24 for the following public purposes, including any applicable architects'and engineers' fees:
- 25 as a grant to the County Government of Harford County for the paving of the parking lot,
- 26 the installation of an elevator and a sprinkler system, improvement andupgrading of
- 27 utilities, equipping, repair, renovation, reconstruction, and expansionof the Highland
- 28 Commons building in Harford County for use as a community center that will include a
- 29 senior center, library reading room, school for children with special needs, and other
- 30 community facilities for the citizens of Harford County.
- 31 (4) An annual State tax is imposed on all assessable property in the State in rate
- 32 and amount sufficient to pay the principal of and interest on the bonds, as and when due

- 1 and until paid in full. The principal shall be discharged within 15 years after the date of 2 issuance of the bonds.
- 3 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 4 June 1, 1996.
