9 10	(C) (1) THE ADVISORY COMMITTEE SHALL CONSIST OF 13 MEMBERS APPOINTED BY THE GOVERNOR.

12	(I) FOUR SHALL BE PUBLIC MEMBERS;
13 14	(II) THREE SHALL REPRESENT HEALTH MAINTENANCE ORGANIZATIONS;
15 16	(III) TWO SHALL REPRESENT LICENSED HEALTH CARE PRACTITIONERS;
17	(IV) ONE SHALL REPRESENT HOSPITALS;
18 19	(V) ONE SHALL REPRESENT THE DEPARTMENT OF HEALTH AND MENTAL HYGIENE;
20 21	(VI) ONE SHALL REPRESENT THE MARYLAND INSURANCE ADMINISTRATION; AND
