4 FOR the purpose of authorizing the Carroll County Board of License Commissioners to
5 impose a fee on applicants for alcoholic beverages licenses; altering the fees for the
6 transfer and assignment of alcoholic beverages licenses; renumbering; and generally
7 relating to alcoholic beverages in Carroll County.

2 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
3 MARYLAND, That Section(s) 10-104(o), (c), (d), (d-1), (e), (p), (f), (g), (h), (n), (l), (i),
4 (i-1), (j), (k), and (m), respectively, of Article 2B - Alcoholic Beverages of the Annotated
5 Code of Maryland be renumbered to be Section(s) 10-104(c), (d), (e), (f), (g), (j), (k),
6 (n), (o), (q), (r), (s), (u), (w), (x), and (y), respectively.

7 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland
8 read as follows:

9 **Article 2B - Alcoholic Beverages**

10 10-104.

11 (H) (1) THIS SUBSECTION APPLIES ONLY IN CARROLL COUNTY.

12 (2) THE BOARD OF LICENSE COMMISSIONERS MAY CHARGE A FEE NOT
13 TO EXCEED \$500 FOR THE PROCESSING OF AN APPLICATION FOR A NEW ALCOHOLIC
14 BEVERAGES LICENSE.

16 (h) (1) This subsection applies only in Carroll County.

17 (2) The fee for transfer of a license is [~~\$50~~] \$350, in addition to the costs of
18 publication and notice. This fee is not refundable.

19 (3) The fee for assignment of a license to another person is [~~\$50~~] \$350. [Of
20 this fee, \$25 is not refundable, but the excess of the fee over \$25 maybe refunded in the
21 discretion of the Board.]

22 (4) A transfer or assignment of license, or both, may not be made until the
23 Board has been satisfied that all State and local real and personal property taxes owed by
24 the transferor or assignor of the license, or both, have been paid.

25 SECTION 3. AND BE IT FURTHER ENACTED, That, in § 10-104 of Article 2B
26 of the Annotated Code as enacted by this Act, where there is no statute applicable to a
27 jurisdiction in the standard alphabetical arrangement of jurisdictions created by this Act,
28 the publishers of the Annotated Code of Maryland, the Michie Company, shall designate
29 the subsection as "reserved".

30 SECTION 4. AND BE IT FURTHER ENACTED, That this Act shall take effect
31 October 1, 1996.
