2 **Creation of a State Debt - Baltimore Children's Museum -~~Maryland Consolidated~~**3 **~~Capital Bond Loan of 1995 and Baltimore Children's Museum Loan of 1995~~**

4 FOR the purpose of authorizing the creation of a State Debt not to exceed \$1,000,000,
 5 the proceeds to be used as a grant to the Baltimore Children's Museum, Inc. for
 6 certain planning, acquisition, development, or improvement purposes; providing for
 7 disbursement of the loan proceeds, subject to a requirement that the grantee
 8 provide and expend a matching fund; requiring the grantee to grant and convey to
 9 the Maryland Historical Trust a historic preservation easement; clarifying the use of
 10 the proceeds of the grant; and providing generally for the issuance and sale of bonds
 11 evidencing the loan; ~~amending Chapter 115 of the Acts of the General Assembly of~~
 12 ~~1994, as amended by Chapter 131 of the Acts of the General Assembly of 1995, to~~

24 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
 25 MARYLAND, That:

1 (1) The Board of Public Works may borrow money and incur indebtedness on
 2 behalf of the State of Maryland through a State loan to be known as the Baltimore
 3 Children's Museum Loan of 1996 in a total principal amount equal to the lesser of (i)
 4 \$1,000,000 or (ii) the amount of the matching fund provided in accordance with Section
 5 1(5) below. This loan shall be evidenced by the issuance, sale, and delivery of State
 6 general obligation bonds authorized by a resolution of the Board of Public Works and
 7 issued, sold, and delivered in accordance with §§ 8-117 through 8-124 of the State
 8 Finance and Procurement Article and Article 31, § 22 of the Code.

9 (2) The bonds to evidence this loan or installments of this loan may be sold as a
 10 single issue or may be consolidated and sold as part of a single issue of bonds under §
 11 8-122 of the State Finance and Procurement Article.

12 (3) The cash proceeds of the sale of the bonds shall be paid to the Treasurer and
 13 first shall be applied to the payment of the expenses of issuing, selling, and delivering the
 14 bonds, unless funds for this purpose are otherwise provided, and then shall be credited on
 15 the books of the Comptroller and expended, on approval by the Board of Public Works,
 16 for the following public purposes, including any applicable architects' and engineers' fees:
 17 as a grant to the Baltimore Children's Museum, Inc. (referred to hereafter in this Act as
 18 "the grantee") for the acquisition of real property and for the planning, design,
 19 construction, alteration, ~~and renovation of, for the provision of equipment and~~
 20 ~~furnishings for, and for the installation of exhibits at,~~ renovation, furnishing, and capital
 21 equipping of the Baltimore Children's Museum, to be located at Market Place in
 22 Baltimore City, adjacent to and including an existing open-air plaza, ~~the grant to include~~
 23 including expenses incurred by the grantee for:

24 (a) the preparation of a master plan for the area immediately surrounding
 25 and related to the Children's Museum;

26 (b) the securing of third party construction; and development ~~and~~
 27 management of services in connection with the planning, design, construction, alteration,
 28 renovation, equipping, and furnishing of the Children's Museum; and

29 (c) the planning, design, construction, and purchase of ~~exhibits~~ furnishings,
 30 fixtures, and capital equipment for the Children's Museum.

31 (4) An annual State tax is imposed on all assessable property in the State in rate
 32 and amount sufficient to pay the principal of and interest on the bonds, as and when due
 33 and until paid in full. The principal shall be discharged within 15 years after the date of
 34 issuance of the bonds.

35 (5) Prior to the payment of any funds under the provisions of this Act for the
 36 purposes set forth in Section 1(3) above, the grantee shall provide and expend a matching
 37 fund. No part of the grantee's matching fund may be provided, either directly or
 38 indirectly, from funds of the State, whether appropriated or unappropriated. No part of
 39 the fund may consist of real property, ~~in kind contributions, or funds expended prior to~~
 40 ~~the effective date of this Act, or in kind contributions.~~ The fund may consist of funds
 41 expended prior to the effective date of this Act, including grant funds received from the
 42 Mayor and City Council of Baltimore or funds received from private sources, all of which
 43 the grantee has expended for uses permitted under this Act or for other costs and
 44 expenses incurred by the grantee in the planning, design, construction, alteration,

1 renovation, furnishing, and equipping of the Children's Museum, and in the planning,
 2 design, acquisition, fabrication, and installation of exhibits to be displayed in the
 3 Children's Museum. In case of any dispute as to the amount of the matching fund or what
 4 money or assets may qualify as matching funds, the Board of Public Works shall
 5 determine the matter and the Board's decision is final. The grantee has until June 1,
 6 1998, to present evidence satisfactory to the Board of Public Works that a matching fund
 7 will be provided. If satisfactory evidence is presented, the Board shall certify this fact and
 8 the amount of the matching fund to the State Treasurer, and the proceeds of the loan
 9 equal to the amount of the matching fund shall be expended for the purposes provided in
 10 this Act. Any amount of the loan in excess of the amount of the matching fund certified
 11 by the Board of Public Works shall be canceled and be of no further effect.

12 (6) ~~(a)~~ As provided in § 8-127(b)(1)(~~ii~~)(i) of the State Finance and
 13 Procurement Article, the grantee may expend the proceeds of the grant for expenses
 14 incurred by the grantee in connection with the planning, design, construction, ~~and~~

 16 furnishing, as permitted in this Act.

17 ~~(b) The improvements for which the funds are expended are not required to~~

20 (7) (a) Prior to the issuance of the bonds, the grantee shall grant and convey to
 21 the Maryland Historical Trust a perpetual preservation easement to the extent of its
 22 interest:

23 (i) On the land or such portion of the land acceptable to the Trust;

24 and

25 (ii) On the exterior and interior, where appropriate, of the historic
 26 structures.

27 (b) The easement must be in form and substance acceptable to the Trust
 28 and the extent of the interest to be encumbered must be acceptable to the Trust.
