BE IT ENACTED BY THE GENERAL ASSEMBLY OF 15 16 MARYLAND, That the Laws of Maryland read as follows: 17 **Article - Business Regulation** 18 3-102. 19 (a) The General Assembly finds that: 20 (1) an unsafe amusement attraction is likely to cause serious and

1 2 ₁	(2) for the welfare of the people of the State, these injuries must be prevented and the public must be protected from unsafe amusement attractions; AND
	(3) COMPLIANCE BY THE PUBLIC WITH SAFETY INSTRUCTIONS AND WARNINGS FROM OPERATORS OF AMUSEMENT ATTRACTIONS IS ESSENTIAL TO PREVENTING THESE INJURIES.
	(b) The purpose of this title is to ensure, as far as possible, the safety of the public in the use of amusement attractions at carnivals, fairs, and amusement parks in the State by providing for:
9	(1) adoption of safety regulations;
10	(2) an effective enforcement and compliance program; [and]
11	(3) reporting procedures on the safety of amusement attractionsthat:
12	(i) help to achieve the purpose of this title; and
13	(ii) describe accurately the hazards of amusement attractions; AND
16	(4) EDUCATION OF THE PUBLIC, TO THE EXTENT PRACTICABLE, THAT COMPLIANCE WITH ALL LAWFUL REQUIREMENTS THAT RELATE TO THE USE OF AMUSEMENT ATTRACTIONS IS ESSENTIAL FOR THE SAFE OPERATION OF AMUSEMENT ATTRACTIONS.

19 20	(A) In addition to any duties set forth elsewhere, the Commissioner shall adopt safety regulations for the maintenance and operation of amusement attractions.
	(B) THE COMMISSIONER MAY ADOPT REGULATIONS THAT RELATE TO THE USE OF AMUSEMENT ATTRACTIONS TO ASSIST IN THE PREVENTION OF CONDUCT THAT MAY CAUSE OR CONTRIBUTE TO INJURIES.
