	(a) Unless exempted under subsection (b) of this section, an entity shall register the Ethics Commission as provided in this subtitle, and shall be a"regulated rist" for the purposes of this title, if, during a reporting period, the entity:

39 40	(c) (1) Except for providing the authorization required by § 15-702 of this subtitle and the report required by § 15-704(c) of this subtitle, an entity that compensates

- 1 one or more regulated lobbyists, and that reasonably believes that all expenditures
- 2 requiring registration will be reported by the regulated lobbyist or lobbyists, is exempt
- 3 from the registration and reporting requirements of this subtitle if the entity engages in
