- 23 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

4 (2) If a vacancy occurs during the term of a member, the appointing 2 authority shall appoint another individual to serve the remainder of the term. 3 (d) A member of the [Commission] COUNCIL: 4 (1) may not receive compensation for duties performed as a member of the 5 [Commission] COUNCIL; but 6 (2) is entitled to reimbursement for expenses under the Standard State 7 Travel Regulations, as provided in the State budget. 8 [(e) (1) After consultation with the Governor, the President of the Senate of 9 Maryland, and the Speaker of the House of Delegates, the Commission shall appoint an 10 Executive Director who shall serve at the pleasure of the Commission. 11 (2) The Executive Director shall: (i) be thoroughly experienced in the fiscal and operational policies 12 13 and practices of the State government and preferably have experience in he private 14 sector; 15 (ii) make recommendations to the Commission concerning: 16 1. the hiring of permanent and part-time staff, who shall be unclassified State employees and serve at the pleasure of the ExecutiveDirector; and 18 2. the employment of consultants and professional personnel on 19 a contractual basis; 20 (iii) manage the day-to-day operations of the Commission; 21 (iv) perform other functions that the Commission assigns; and 22 (v) receive an annual salary as determined in the State budget. 23 (f) The Attorney General shall assign one assistant Attorney Generalto the 24 Commission who shall provide legal aid, advice, and counsel required bythe Commission. 25 (g) As agreed upon by the Governor, the President of the Senate of Maryland, 26 and the Speaker of the House of Delegates, the Commission shall, to the extent possible, utilize existing office space and equipment in State facilities. (h) Subject to the approval of the President of the Senate of Maryland, the 28 29 Speaker of the House of Delegates, the Director of the Department of Fiscal Services, 30 and the Director of the Department of Legislative Reference, the Commission may utilize 31 personnel from the Department of Fiscal Services and the Department of Legislative 32 Reference with due regard for the dictates of practicality.

23 24	(a) Except as provided in subsection (b) of this section, the State, the [Commission] COUNCIL, and the members of the [Commission] COUNCIL are not personally liable in any action for damages because of acts committed or omitted by the [Commission] COUNCIL, any member of the [Commission] COUNCIL, or any employee of the [Commission] COUNCIL, in the performance of their duties.
	(b) The immunity from liability provided in subsection (a) of this section does not apply in the case of willful malfeasance or breach of trust by the State, the [Commission] COUNCIL, or any of its members or staff.
