Senate Bill 485 (Senator Young) Economic and Environmental Affairs

### **Geriatric Nursing Assistants - Training and Certification**

This bill requires specified training and certification for "geriatric nursing assistants." The Secretary of Health and Mental Hygiene is required to adopt regulations providing for the evaluation and certification of geriatric nursing assistants, including the establishment of a registry for that occupation.

## **Fiscal Summary**

**State Effect:** General fund expenditures would increase by \$78,400 in FY 1997. Future years reflect annualization and inflation. Revenues would not be affected.

### **Fiscal Analysis**

**Background:** The Licensing and Certification Administration (LCA) of the Department of Health and Mental Hygiene (DHMH) currently has similar certification and registry requirements for approximately 23,000 geriatric nursing assistants working in nursing homes. The LCA estimates that there could be at least another 25,000 uncertified assistants at work in hospitals, hospices, home health agencies, and other related facilities. It is known, for instance, that Mercy Hospital in Baltimore City, an average sized facility, has 285 beds and approximately 300 nursing assistants.

**State Revenues:** No effect. The fees that geriatric nursing assistants pay for certification and registration are paid to a private sector contractor under an ongoing contractual arrangement with the department. While DHMH maintains the registry of certified geriatric nursing assistants, the State derives no revenue from either the certification of these assistants or the maintenance of the existing registry. The LCA anticipates having the same arrangement for the geriatric nursing assistants covered by this bill.

**State Expenditures:** General fund expenditures could increase by an estimated \$78,442 in fiscal 1997, which reflects the bill's October 1, 1996 effective date. This estimate reflects the cost of hiring a Health Facilities Survey Nurse and an Office Secretary to perform the coordination, direct contact, and investigatory functions related to the certification and registration of an estimated additional 25,000 geriatric nursing assistants at health care facilities statewide. It includes salaries of \$34,644, fringe benefits, one-time start-up costs, and ongoing operating expenses.

Future year expenditures reflect (1) full salaries with 3.5% annual increases and 3% employee turnover; and (2) 2% annual increases in ongoing operating expenses.
