#### **Sales and Use Tax - Exemptions**

This bill repeals 24 current exemptions from the sales and use tax.

The bill is effective July 1, 1996.

## **Fiscal Summary**

**State Effect:** General fund revenues could increase by \$105.5 million in FY 1997. Future year estimates reflect historical growth trends. Expenditures would not be affected.
