AMENDMENTS TO SENATE BILL NO. 510

AMENDMENT NO. 1

On page 1, in the sponsor line, strike "Senator Baker" and substitute "<u>Senators Baker, Frosh, Kelley, Green, Stone, Jimeno, Hughes, Haines, Forehand, Colburn, Ferguson, and Middlebrooks</u>".

AMENDMENT NO. 2

On page 1, in line 10, after "revocation;" insert "<u>requiring a final report under modified administration to include certain information;</u>"; in line 13, after "administration;" insert "<u>providing for a certain period of limitations for certain claims or demands under certain circumstances;</u>"; in line 19, after "2-206" insert "<u>and 10-103(a)</u>"; and in line 24, strike "5-709" and substitute "<u>5-710</u>".

AMENDMENT NO. 3

On page 4, in line 28, strike "LEGATEES AND HEIRS OF THE" and substitute "RESIDUARY LEGATEES OF A TESTATE DECEDENT AND THE HEIRS AT LAW OF AN INTESTATE".

On page 5, in line 5, strike "LEGATEES AND HEIRS OF THE" and substitute "<u>RESIDUARY LEGATEES OF A TESTATE DECEDENT AND THE HEIRS AT LAW OF AN INTESTATE</u>".

AMENDMENT NO. 4

On page 6, after line 20, insert:

"<u>5-707.</u>

A FINAL REPORT UNDER MODIFIED ADMINISTRATION SHALL INCLUDE:

(1) A STATEMENT REPRESENTING THE CONTINUED QUALIFICATION

FOR MODIFIED ADMINISTRATION;

- (2) AN ITEMIZED SCHEDULE OF THE DECEDENT'S PROPERTY AND THE BASIS OF ITS VALUATION;
- (3) AN ITEMIZED SCHEDULE OF LIENS, DEBTS, TAXES, AND FUNERAL EXPENSES OF THE DECEDENT AND ADMINISTRATION EXPENSES OF THE ESTATE; AND
- (4) SCHEDULES SETTING FORTH DISTRIBUTIVE SHARES OF THE ESTATE AND THE APPLICABLE INHERITANCE TAX."; in line 21, strike "5-707." and substitute "5-708.".

On page 7, in lines 8 and 13, strike "5-708." and "5-709.", respectively, and substitute "5-709." and "5-710.", respectively.

AMENDMENT NO. 5

On page 7, after line 16, insert:

"10-103.

- (a) (1) If no action or proceeding involving the personal representative is pending one year after the close of the estate pursuant to § 5-709 OF THIS ARTICLE OR § 10-101 OF THIS SUBTITLE, the personal representative shall be discharged from any claim or demand of any interested person.
- (2) The rights so barred do not include rights to recover from a personal representative for fraud, material mistake, or substantial irregularity.".
