AMENDMENT NO. 2

AMENDMENT NO. 5

On page 5, in line 12, strike "and" and substitute "<u>PRINCIPALS</u>, <u>PARTNERS</u>,"; in line 13, after "addresses" insert "<u>AND TELEPHONE NUMBERS</u>"; in line 23, strike "The" and substitute "<u>SUBJECT TO THE HEARING PROVISIONS OF TITLE 2 OF THIS ARTICLE, THE</u>"; and in line 29, strike "OR ENGAGED IN FRAUD".

AMENDMENT NO. 6

AMENDMENT NO. 7

On page 7, in line 21, strike "OR"; in line 22, strike "RENEWAL"; in line 23, strike "FROM TIME TO TIME"; and in line 29, strike "producer" and substitute "BROKER".

AMENDMENT NO. 8

On page 10, strike in their entirety lines 1 and 2.

AMENDMENT NO. 10

On page 10, in line 18, before "The" insert "(I)"; in the same line, strike "DELIVER OR"; after line 19, insert:

"(II) WITH RESPECT TO COMMERCIAL AUTOMOBILE, FIRE, OR LIABILITY INSURANCE, THE PREMIUM FINANCE COMPANY SHALL DELIVER THE NOTICE IN ACCORDANCE WITH THE INSURED'S REQUEST UNDER § 23-401.1(B) OF THIS SUBTITLE.";

strike beginning with the comma in line 23 down through "INSURED" in line 25; and in lines 35 and 36, in each instance, strike the bracket.

AMENDMENT NO.11
