DIRECT PREMIUM, TO THE EXTENT ALLOCABLE TO THIS STATE AND WRITTEN IN THE STATE DURING THE PRECEDING CALENDAR YEAR, MULTIPLIED BY THE BASE ASSESSMENT RATE DETERMINED UNDER SUBSECTION (D) OF THIS SECTION".

On page 41, strike beginning with "THE" in line 20 down through "STATE" in line 23 and substitute "THE INSURANCE REGULATION FEE SHALL BE AN AMOUNT THAT WILL BE ADEQUATE TO PROPERLY REGULATE THE INSURANCE BUSINESS IN THE STATE"; in line 24, strike "CONSTRUED AS A" and substitute "USED TO"; in line 25, strike "OR EXCISE" and substitute "A TAX"; and strike beginning with "IN" in line 27 down through "YEAR" in line 33 and substitute "EACH INSURER SHALL PAY AN INSURANCE REGULATION FEE THAT IS THE PRODUCT OF THE INSURER'S ADJUSTED GROSS DIRECT PREMIUM, TO THE EXTENT ALLOCABLE TO THIS STATE AND WRITTEN IN THE STATE DURING THE PRECEDING CALENDAR YEAR, MULTIPLIED BY THE BASE ASSESSMENT RATE DETERMINED UNDER SUBSECTION (D) OF THIS SECTION".

#### AMENDMENT NO. 5
