The parcel should be of sufficient size and configuration to allow the design and construction of a 96-bed hospital facility with all necessary ancillary support space. The parcel shall not be less than 22 acres in size;

- (3) the Department of General Services has certified that the new hospital site has adequate sewer and road infrastructure to service the new facility;
- the Departments of Health and Mental Hygiene and General Services have reported to the budget committees on the feasibility of designing the replacement facility to allow initial construction of up to 78 beds with support spaces sized to allow the future addition of beds to the maximum of 96; and
- (5) the committees have reviewed and commented on the report or 45 days have elapsed from the date the committees received the report.

## AMENDMENT NO. 16

On page 6 strike beginning with "<u>, provided</u>" in lines 33 and 34 down through and including "<u>funds</u>" in line 16 on page 7 and substitute:

"It is the intent of the General Assembly that the State assume the full cost of:

- (1) the design of the addition to and renovation of the State Library Resource Center (SLRC); and
- (2) the construction of the addition to the State Library Resource Center.

It is further the intent of the General Assembly that the cost of renovating the existing facility shall be shared between the State, Baltimore City and, to the extent possible, private sources.

The State Department of Education and the State Library Resource Center shall submit a report to the budget committees by September 1, 1997:

(1) detailing the history of operating and capital funding support for SLRC by the State and by Baltimore City and indicating the level of future operating support which will be required of

each; and

(2) providing a strategic plan for SLRC to increase the use of SLRC by other libraries through increased use of new technology, enhancement of collections, and provision of specialized services (e.g., manuscript restoration/preservation). The plan should indicate the costs associated with these initiatives.

The Department of General Services shall verify the reasonableness of the cost estimates provided by the library's consultants and provide this information with the submission of the Fiscal Year 1999 budget".

- (3) An explanation of the alternatives for providing additional space and upgrading the library that were considered in developing the current plan.

The committees shall have 45 days to review and comment on the report prior to expenditure of these funds".
