#### AMENDMENTS TO HOUSE BILL NO. 934

(First Reading File Bill)

### AMENDMENT NO. 1

On page 1, in line 3, strike "Code Revised -"; and strike beginning with "revising" in line 5 down through "County" in line 6 and substitute "altering the conditions under which a Class B beer, wine and liquor licensee in Montgomery County may obtain additional Class B beer, wine and liquor licenses for restaurants located within certain areas; defining certain terms; making technical and stylistic changes".

### AMENDMENT NO. 2

On page 4, in line 35, strike "-MAJOR MALL"; in line 36, strike "EITHER"; and in the same line, strike the colon.

On page 5, in line 1, strike "(I)"; strike beginning with "; OR" in line 2 down through "AREA" in line 4; in line 7, strike "TO DIFFERENT APPLICANTS"; in lines 8 and 9, strike ": (I) TWO LICENSES" and substitute "ONE LICENSE"; strike beginning with "FOR" in line 9 down through "AREA" in line 12 and substitute "TO DIFFERENT APPLICANTS"; after line 12, insert:

"(H) (1) A LICENSEE MAY OBTAIN ONE ADDITIONAL LICENSE FOR PREMISES
WHICH MEET THE QUALIFICATIONS SPECIFIED IN THIS SUBSECTION. FOR
IDENTIFICATION PURPOSES, THIS ADDITIONAL LICENSE MAY BE REFERRED TO AS A
"MAJOR MALL" LICENSE.

- (2) THE RESTAURANT SHALL BE LOCATED WITHIN AN ENCLOSED RETAIL MALL ANYWHERE IN THE COUNTY THAT HAS AT LEAST 700,000 SQUARE FEET OF GROSS FLOOR AREA.
- (3) THE REQUIREMENT THAT THE HOLDER HAS BEEN A LICENSEE FOR 3 YEARS DOES NOT APPLY TO THIS SUBSECTION.

# (4) THE BOARD MAY GRANT A MAXIMUM OF ONE LICENSE OF THIS TYPE FOR USE IN EACH RETAIL MALL HAVING AT LEAST 700,000 SQUARE FEET OF GROSS FLOOR AREA.";

in line 13, strike "(H)" and substitute "(I)"; in line 30, after "4." insert "<u>A.</u>"; in line 31, strike "-MAJOR MALL"; and in the same line, after "LICENSE" insert "; <u>OR</u>

On pages 5 and 6, strike in their entirety beginning with line 32 on page 5 through line 7 on page 6, inclusive.

### AMENDMENT NO. 3

On page 6, strike in their entirety lines 25 through 29, inclusive; and in line 30, strike "4." and substitute "3.".
