On page 31 of the Amendments, in line 11 of Amendment No. 13, strike "<u>22.</u>" and substitute "<u>21.</u>"; in the same line, strike "<u>24.</u>" and substitute "<u>23.</u>"; in the same line, strike "<u>31.</u>" and substitute "<u>30.</u>"; in the same line, strike "<u>32.</u>" and substitute "<u>31.</u>"; and in line 13, strike "<u>23.</u>" and substitute "<u>22.</u>".
