(2) THE BOARD AND THE SECRETARY HAVE JOINTLY REVIEWED THE REPORT OF THE COMMITTEE TO WHICH THE REFERRAL WAS MADE UNDER § 14-401(C)(5) OF THIS SUBTITLE; AND

(3) THE BOARD AND THE SECRETARY CONCUR ON APPROPRIATE DISCIPLINARY ACTION.".
