### AMENDMENT NO. 4

On page 4, strike beginning with "(I)" in line 6 down through "OWNER" in line 10 and substitute "SUBJECT TO REASONABLE RULES ADOPTED BY THE GOVERNING BODY UNDER § 11-111 OF THIS SUBTITLE, A GOVERNING BODY OR COMMITTEE SHALL PROVIDE A DESIGNATED PERIOD OF TIME DURING A MEETING TO ALLOW UNIT OWNERS AN OPPORTUNITY TO COMMENT ON ANY MATTER RELATING TO THE CONDOMINIUM".

On page 6, strike beginning with "(I)" in line 32 down through "OWNER" in line 36 and substitute "SUBJECT TO REASONABLE RULES ADOPTED BY THE GOVERNING BODY, A GOVERNING BODY OR COMMITTEE SHALL PROVIDE A DESIGNATED PERIOD OF TIME DURING A MEETING TO ALLOW LOT OWNERS AN OPPORTUNITY TO COMMENT ON ANY MATTER RELATING TO THE HOMEOWNERS ASSOCIATION".

### AMENDMENT NO. 5

On page 5, in line 5, before the first "A" insert "(A)"; in line 8, after "OPERATION" insert "OF"; in line 9, strike "THAT RELATE" and substitute "RELATING"; in line 10, after "ALL" insert "GENERAL"; in line 11, after "THE" insert "GENERAL"; in the same line, after "ELEMENTS" insert ", SUBJECT TO REASONABLE RULES CONCERNING TIME, PLACE, AND MANNER ADOPTED BY THE GOVERNING BODY UNDER § 11-111 OF THIS SUBTITLE"; in the same line, strike "OR" and substitute "AND"; and after line 13, insert:

"(B) THE COSTS OF DUPLICATION, DISTRIBUTION, OR REMOVAL OF MATERIALS PREPARED BY A UNIT OWNER SHALL BE THE RESPONSIBILITY OF THOSE DISTRIBUTING THE INFORMATION OR CIRCULATING THE PETITIONS.

(C) THIS SECTION MAY NOT BE CONSTRUED TO REQUIRE THE GOVERNING BODY TO DUPLICATE OR DISTRIBUTE MATERIAL PREPARED BY A UNIT OWNER.".

On page 7, in line 28, before the first "A" insert "(A)"; in line 31, after "OPERATION" insert "OF"; in line 32, strike "THAT RELATE" and substitute "RELATING"; in line 34, after "AREAS" insert ", SUBJECT TO REASONABLE RULES CONCERNING TIME, PLACE, AND MANNER ADOPTED BY THE GOVERNING BODY"; in the same line, strike "OR" and substitute "AND"; and after line 37, insert:
