BE IT ENACTED BY THE GENERAL ASSEMBLY OF 12 13 MARYLAND, That the Laws of Maryland read as follows: 14 Article 2B - Alcoholic Beverages 15 2-207. 16 (a) A Class 6 pub-brewery license shall be issued: 17 (1) By the State Comptroller; 18 (2) Only to a holder of a Class B beer, wine and liquor (on-sale) license that 19 is issued for use on the premises of a restaurant located in the jurisdictions listed in 20 paragraph (3) of this subsection; and 21 (3) Only in the following jurisdictions:

2 1 (i) Anne Arundel County; 2 (ii) Anne Arundel County - City of Annapolis; 3 (iii) Baltimore City; 4 (iv) Baltimore County; (v) CALVERT COUNTY; 5 6 (VI) The thirteenth election district of Carroll County; 7 [(vi)] (VII) Cecil County; [(vii)] (VIII) Charles County; 8 9 [(viii)] (IX) Dorchester County; 10 [(ix)] (X) Frederick County; 11 [(x)] (XI) Garrett County; [(xi)] (XII) Harford County; 12 13 [(xii)] (XIII) Kent County; 14 [(xiii)] (XIV) Montgomery County; 15 [(xiv)] (XV) Queen Anne's County; [(xv)] (XVI) Washington County; 16 17 [(xvi)] (XVII) Wicomico County; and 18 [(xvii)] (XVIII) Worcester County. 19 (b) A holder of a Class 6 pub-brewery license: 20 (1) May brew malt beverages at a single location for consumption on the 21 restaurant premises; and 22 (2) Is limited to the brewing of 2,000 barrels of malt beverage each calendar 23 year. 24 (c) The pub-brewery premises shall be located immediately adjacent to the 25 restaurant where the brewed beverage is to be sold to the public. 26 (d) The Class 6 pub-brewery license is void if: 27 (1) The restaurant ceases to be operated as a restaurant; or 28 (2) The holder's Class B beer, wine and liquor (on-sale) license is revoked 29 or transferred to a different location. 30 (e) If the holder's Class B beer, wine and liquor (on-sale) license is suspended,

31 the Class 6 pub-brewery license shall be suspended for the same period of time.

	(4) A holder of a Class 6 pub-brewery license may not sell malt beverages to any retail alcoholic beverages licensee in this State for the purpose of a subsequent sale or distribution of that malt beverage under the retail license.
22	(h) In Montgomery County, a holder of a Class 6 pub-brewery license shall enter into a written agreement with the Department of Liquor Control for Montgomery County for the sale and resale of all malt beverages brewed under this license in accordance with this article.
24	(i) (1) This subsection applies only in Wicomico County.
27	(2) Before the Office of the Comptroller of this State may issue a pub-brewery license, it shall forward a copy of the application to the Board of License Commissioners. The Board shall review the application, hold a public hearing on the application, and recommend to the Office whether or not to grant the license.

4 1 (iii) Baltimore County; 2 (iv) The City of Annapolis; 3 (v) Anne Arundel County; 4 (vi) CALVERT COUNTY; 5 (VII) The thirteenth election district of Carroll County; 6 [(vii)] (VIII) Charles County; 7 [(viii)] (IX) Dorchester County; 8 [(ix)] (X) Frederick County; 9 [(x)] (XI) Garrett County; 10 [(xi)] (XII) Howard County; 11 [(xii)] (XIII) Montgomery County; and [(xiii)] (XIV) Prince George's County; and 12 13 (3) (i) Only to a holder of a Class B beer, wine and liquor (on-sale) 14 license that is issued for use on the premises of a restaurant located in a jurisdiction listed 15 in paragraph (2) of this subsection; or 16 (ii) To a holder of a Class D alcoholic beverages license that is issued 17 for use on the premises of the existing Class D license if the premises are located in the 18 22nd Alcoholic Beverages District of Prince George's County. 19 (c) (1) A holder of a Class 7 micro-brewery license: 20 (i) May brew and bottle malt beverages at a single location; and 21 (ii) May not brew more than 10,000 barrels of malt beverage each 22 calendar year. 23 (2) In Allegany County only, the holder of a Class 7 license: 24 (i) May brew in one location and may contract for the bottling of the 25 malt beverage in another location; and 26 (ii) Need not meet the hotel/motel requirements for a Class B beer, 27 wine and liquor licensee but shall meet the requirements for those Class B restaurants. 28 (d) (1) The on-sale privilege authorizes the holder to sell at retail beer brewed 29 under this license to customers for consumption on the licensed premises. (2) The off-sale privilege authorizes the holder to sell and deliver beer 31 brewed under this license to: 32 (i) Any wholesaler licensed under this article to sell beer in this State; 33 or

	(3) (i) This paragraph applies only in the City of Annapolis, Anne Arundel County, Baltimore City, Baltimore County, CALVERT COUNTY, Charles County, Dorchester County, Frederick County, Howard County, and Prince George's County.
	(ii) The holder may sell at retail beer brewed under this license to customers for consumption off the licensed premises in refillable containers that are sealed by the micro-brewery licensee at the time of each refill.
9	(e) A holder of a Class 7 micro-brewery license:
10 11	(1) May not own, operate or be affiliated with any other manufacturer of beer; and
12 13	(2) Notwithstanding § 2-201(b) of this article, may not be granted a wholesale alcoholic beverages license.
	(f) (1) The hours and days for consumer sales under this license are as established for a Class B license in the respective jurisdictions listed in subsection (b)(2) of this section.
	(2) For Class D licensees in the 22nd Alcoholic Beverages District in Prince George's County only, the hours and days for consumer sales under this license are as established for a Class D license in Prince George's County.
22	(g) In Montgomery County, a holder of a Class 7 micro-brewery license shall enter into a written agreement with the Department of Liquor Control for Montgomery County for the sale and resale of malt beverages brewed under this license in accordance with this article.
