5	district in Calvert County to be accompanied by a certain opinion and certification
6	concerning the homeowners association that presents the petition under certain

8	of a special taxing district in Calvert County to pay in advance certain costs
9	associated with a certain notice of a hearing on the petition; and generally relating
10	to the duties of homeowners associations in the creation of special taxing districts in

6	(2) (I) The notice shall be given by sending a copy of the notice by mail to the owner of record of each parcel of property proposed to be assessed and by publication of a copy of the notice at least once a week for 4 weeks in at least one newspaper having general circulation in Calvert County.
10	(II) THE HOMEOWNERS ASSOCIATION THAT PETITIONED FOR THE CREATION OF A SPECIAL TAXING DISTRICT SHALL PAY IN ADVANCE THE COSTS ASSOCIATED WITH THE PREPARATION, MAILING, AND PUBLICATION OF THE NOTICE AS PROVIDED UNDER SUBPARAGRAPH (I) OF THIS PARAGRAPH.
12 13	(3) The clerk to the county commissioners shall present at the hearing a certificate of publication and mailing of copies of the notice.
14	(4) The certificate shall be deemed proof of notice.
15 16	(5) Failure of any owner to receive the mailed copy does not invalidate the proceedings.
	(6) The date of hearing shall be set at least 10 and not more than 30 days after the clerk to the county commissioners shall have completed publication and service of notice as provided in this section.
20 21	(7) After the hearing, the county commissioners may vote to create the special taxing district and set the tax levy for the district.
	(d) Any amendment to the boundaries or stated purpose of the special taxing district or to the amount of levy set for the district shall be made only in accordance with the procedures set forth in this section for original creation of the special taxing district.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
