- 2 The Children's Guild, Inc. Loan of 1990
- 3 FOR the purpose of amending Chapter 447 of the Acts of the General Assembly of 1990,
- 4 The Children's Guild, Inc. Loan of 1990, to alter the purpose for which the
- 5 proceeds of the bonds may be used.
- 6 BY repealing and reenacting, with amendments,
- 7 Chapter 447 of the Acts of the General Assembly of 1990
- 8 Section 1
- 9 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 10 MARYLAND, That the Laws of Maryland read as follows:
- 11 Chapter 447 of the Acts of 1990
- 12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 13 MARYLAND, That:
- 14 (1) The Board of Public Works may borrow money and incur indebtedness on
- 15 behalf of the State of Maryland through a State loan to be known as The Children's
- 16 Guild, Inc. Loan of 1990 in the total principal amount of \$500,000. This loan shall be
- 17 evidenced by the issuance, sale, and delivery of State general obligation bonds authorized
- 18 by a resolution of the Board of Public Works and issued, sold, and delivered in
- 19 accordance with §§ 8-117 through 8-124 of the State Finance and Procurement Article
- 20 and Article 31, § 22 of the Code.
- 21 (2) The bonds to evidence this loan or installments of this loan may be sold as a
- 22 single issue, or may be consolidated and sold as part of a single issue of bonds under §
- 23 8-122 of the State Finance and Procurement Article.

- 1 (3) The cash proceeds of the sale of the bonds shall be paid to the Treasurer and
- 2 first shall be applied to the payment of the expenses of issuing, selling, and delivering the
- 3 bonds, unless funds for this purpose are otherwise provided, and then shall be credited on
- 4 the books of the Comptroller and expended, on approval by the Board of Public Works,
- 5 for the following public purposes, including any applicable architects' and engineers' fees:
- 6 as a grant to The Children's Guild, Inc. for the purchase [and] OR renovation of a
- 7 building, REPAIR, RENOVATION, RECONSTRUCTION, AND EXPANSION OF, FOR THE
- 8 PROVISION OF CAPITAL EQUIPMENT FOR, AND FOR SITE IMPROVEMENTS TO,
- 9 FACILITIES in Baltimore City, THESE FACILITIES to be used as a school and treatment
- 10 center for emotionally disturbed children.
- 11 (4) An annual State tax is imposed on all assessable property in the State in rate
- 12 and amount sufficient to pay the principal of and interest on the bonds, as and when due
- 13 and until paid in full. The principal shall be discharged within 15 years after the date of
- 14 issue of the bonds.
- 15 (5) Prior to the payment of any funds under the provisions of this Act for the
- 16 purposes set forth in Section 1(3) above, The Children's Guild, Inc. shall provide at least
- 17 an equal and matching fund of \$500,000. No part of an applicant's matching fund may be
- 18 provided, either directly or indirectly, from funds of the State, whether appropriated or
- 19 unappropriated. No part of the fund may consist of real property, in kind contributions,
- 20 or funds expended prior to the effective date of the Act. In case of any dispute as to what
- 21 money or assets may qualify as matching funds, the Board of Public Works shall
- 22 determine the matter, and the Board's decision is final. The Children's Guild, Inc. has
- 23 until June 1, 1992 to present evidence satisfactory to the Board of Public Works that the
- 24 matching fund will be provided. If satisfactory evidence is presented, the Board shall
- 25 certify this fact to the State Treasurer and the proceeds of the loan shall be expended for
- 26 the purposes provided in this Act. If this evidence is not presented by June 1, 1992, the
- 27 proceeds of the loan shall be applied to the purposes authorized in § 8-129 of the State
- 28 Finance and Procurement Article.
- 29 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 30 June 1, 1997.
