A BILL ENTITLED

1 AN ACT concerning

2 **Howard County - Alcoholic Beverages**
3 **(1-Day License Fee)**
4 **Ho. Co. 6-97**

5 FOR the purpose of altering the 1-day license fee in Howard County for Class C beer or
6 beer and wine licensees; and generally relating to alcoholic beverages in Howard
7 County.

8 BY repealing and reenacting, with amendments,
9 Article 2B - Alcoholic Beverages

11 Annotated Code of Maryland
12 (1996 Replacement Volume)

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
14 MARYLAND, That the Laws of Maryland read as follows:

15 **Article 2B - Alcoholic Beverages**

16 7-101.

17 (b) (1) (i) Subject to subsection (a) of this section, a special Class C beer
18 license or a special Class C beer and wine license entitles the holder to exercise any of the
19 privileges conferred by the respective classes of licenses for the use of any person holding
20 any bona fide entertainment conducted by any club, society or association at the place
21 described in the license, for a period not exceeding seven consecutive days from the
22 effective date thereof.

23 (ii) The fee is \$5 per day.

24 (2) In Anne Arundel County the fee is \$10 per day.

25 (3) In Baltimore City the fee is \$15 per day.

26 (4) In Baltimore County the fee is \$10 per day, except that for any bona fide
27 religious, fraternal, civic, war veterans', hospital or charitable organization, the fee is \$5.

28 (5) In Carroll County the fee is \$10 per day.

1 (6) In Dorchester County the fee is \$15 per day.

2 (7) In Frederick County the fee is \$10 per day.

3 (8) In Harford County the fee is \$10 per day.

4 (9) IN HOWARD COUNTY THE FEE IS \$15 PER DAY.

5 (10) In Montgomery County the fee is \$15 per day.

6 [(10)] (11) In Prince George's County:

7 (i) Except as provided in item (ii) of this paragraph, the fee is \$25 per
8 day;

9 (ii) For a club, society, or association holding a casino or gambling
10 event, the fee is \$100 per day, which shall be paid by the club, society, or association and
11 shall be considered as part of the club's, society's, or association's special license fee; and

12 (iii) The Board of License Commissioners may deny an application for
13 this license if it is determined that the applicant does not qualify under the provisions of
14 this article.

15 [(11)] (12) In Washington County:

16 (i) The fee for a special Class C beer license is \$15 per day; and

17 (ii) The fee for a special Class C beer and light wine license is \$25 per
18 day.

19 [(12)] (13) In Wicomico County the fee is \$20 per day.

20 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
21 October 1, 1997.
