1 AN ACT concerning

2 Wicomico County - Rights of Redemption - Limit on Reimbursement of Foreclosure 3 Expenses

4 FOR the purpose of providing that in Wicomico County certain persons are not entitled

- 5 to be reimbursed for certain expenses in connection with the foreclosure of a right
- 6 of redemption that are incurred within a certain period after the tax sale; and
- 7 providing for a certain exception.

8 BY repealing and reenacting, with amendments,

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

14 MARYLAND, That the Laws of Maryland read as follows:

15 Article - Tax - Property

16 14-843.

17 (a) Except as provided in subsection (b) of this section, on redemption, the

18 plaintiff or the holder of a certificate of sale is entitled to be reimbursed for expenses

19 incurred in any action or in preparation for any action to foreclose the right of

20 redemption. In addition, the plaintiff or holder of a certificate of sale, on redemption, is

21 entitled to be reimbursed for fees paid for recording the certificate of sale, for attorney's

22 fees in the sum of \$400 for each certificate of sale, for expenses incurred in the

23 publication and service of process by publication, for reasonable fees for a necessary title

24 search, and for taxes, together with interest and penalties on the taxes, arising after the

1 date of sale that have been paid by the plaintiff. The plaintiff or holder of a certificate of 2 sale is not entitled to be reimbursed for any other expenses.

3 (b) (1) Except as provided in paragraph (2) of this subsection, in Anne Arundel
4 County, Baltimore City, Baltimore County, Calvert County, Caroline County, Cecil
5 County, Charles County, Harford County, Howard County, Kent County, Prince George's
6 County, Queen Anne's County, St. Mary's County, [and] Washington County, AND

7 WICOMICO COUNTY, the plaintiff or holder of a certificate of sale is not entitled to be 8 reimbursed for expenses incurred within 4 months after the date of sale.

9 (2) This subsection does not apply to property for which the holder may file 10 a complaint any time after 60 days from the date of sale, pursuant to § 14-833(e) of the 11 Tax - Property Article.

12 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 13 June 1, 1997.
