SECTION 2. AND BE IT FURTHER ENACTED, That, pursuant to Article III, Section 35 of the Constitution of Maryland, this Act may not be construed to extend or apply to the salary or compensation of the State's Attorney for Somerset County, the County Treasurer of Somerset County, the Sheriff of Somerset County, or the County Commissioners of Somerset County in office on the effective date of this Act, but the provisions of this Act concerning the salary or compensation of the State's Attorney for Somerset County, the County Treasurer of Somerset County, the Sheriff of Somerset County, and the County Commissioners of Somerset County shall take effect at the beginning of the next following terms of office.
