- 18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 19 MARYLAND, That Section(s) 8-501, 8-502, and 8-503, respectively, of Article 2B -
- 20 Alcoholic Beverages of the Annotated Code of Maryland be renumbered to be Section(s)
- 21 8-503, 8-504, and 8-501, respectively.
- 22 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland
- 23 read as follows:
- 24 Article 2B - Alcoholic Beverages
- 25 8-502.
- 26 (A) THIS SECTION APPLIES ONLY IN HOWARD COUNTY.
- (B) IN THIS SECTION, "BOARD" MEANS THE BOARD OF LICENSE 27
- 28 COMMISSIONERS.

- $1\,$  (C) THE BOARD MAY ISSUE 7-DAY CLASS GC (GOLF COURSE) BEER, WINE AND 2 LIQUOR LICENSES.
- 3 (D) A LICENSE MAY BE ISSUED ON BEHALF OF AN ORGANIZATION THAT 4 OWNS OR MANAGES A GOLF COURSE WITH A MINIMUM OF 18 HOLES.
- 5 (E) THE ANNUAL LICENSE FEE IS \$1,500.
- 6 (F) THE LICENSE IS FOR THE SALE AND CONSUMPTION OF ALCOHOLIC 7 BEVERAGES ON THE LICENSED PREMISES.
- 8 (G) THE HOURS AND DAYS FOR SALE ARE FOUND IN § 11-514 OF THIS
  9 ARTICLE. HOWEVER, THE BOARD MAY REDUCE THE HOURS AND DAYS FOR SALE
  10 FOR ALL OR A PORTION OF THE LICENSED PREMISES.
- 11 (H) THE BOARD MAY PLACE CONDITIONS ON THE LOCATION OF SALES AND 12 CONSUMPTION, INCLUDING:
- 13 (1) PROHIBITING THE SALE AND CONSUMPTION OF LIQUOR ON 14 SPECIFIED AREAS OF THE LICENSED PREMISES; AND
- 15 (2) PERMITTING THE SALE AND CONSUMPTION OF ONLY BEER AND 16 LIGHT WINE ON SPECIFIED AREAS OF THE LICENSED PREMISES.
- 17 (I) THE BOARD MAY RESTRICT THE SALE OF ALCOHOLIC BEVERAGES TO 18 BEER AND LIGHT WINE IF THE BOARD DETERMINES THAT CIRCUMSTANCES 19 WARRANT.

- 21 (a) Except as otherwise stipulated by the Howard County Board of License 22 Commissioners, in Howard County holders of:
- 23 (3) A 7-DAY CLASS GC LICENSE MAY SELL BEER, WINE AND LIQUOR 24 FROM 11 A.M. TO 2 A.M. THE NEXT DAY, MONDAY THROUGH SUNDAY, INCLUSIVE.
- 25 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 26 October 1, 1997.
