SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
19 MARYLAND, That Section(s) 8-501, 8-502, and 8-503, respectively, of Article 2B -
20 Alcoholic Beverages of the Annotated Code of Maryland be renumbered to be Section(s)
21 8-503, 8-504, and 8-501, respectively.
SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland 3 read as follows:

Article 2B - Alcoholic Beverages

1 2 LIQUOR LICENSES.

3 (D) A LICENSE MAY BE ISSUED ON BEHALF OF AN ORGANIZATION THAT 4 OWNS OR MANAGES A GOLF COURSE WITH A MINIMUM OF 18 HOLES. 9 ARTICLE. HOWEVER, THE BOARD MAY REDUCE THE HOURS AND DAYS FOR SALE 10 FOR ALL OR A PORTION OF THE LICENSED PREMISES.

11 (H) THE BOARD MAY PLACE CONDITIONS ON THE LOCATION OF SALES AND CONSUMPTION, INCLUDING
(1) PROHIBITING THE SALE AND CONSUMPTION OF LIQUOR ON 14 SPECIFIED AREAS OF THE LICENSED PREMISES; AND
(2) PERMITTING THE SALE AND CONSUMPTION OF ONLY BEER AND 16 LIGHT WINE ON SPECIFIED AREAS OF THE LICENSED PREMISES
(I) THE BOARD MAY RESTRICT THE SALE OF ALCOHOLIC BEVERAGES TO 8 BEER AND LIGHT WINE IF THE BOARD DETERMINES THAT CIRCUMSTANCES 9 WARRANT
