A BILL ENTITLED

1 AN ACT concerning

2 Redskins Stadium - Road Construction - Contingent Funding Prohibition

- 3 FOR the purpose of prohibiting the Department of Transportation from expending
- 4 certain funds in and after Fiscal Year 1997 relating to roads and infrastructure for
- 5 the Redskins Stadium in Prince George's County unless the Department provides
- 6 certain notice to the Budget Committees of the General Assembly concerning the
- 7 Department's intent to construct certain road ramps before the scheduled opening
- 8 of the stadium; making this Act an emergency measure; and generally relating to
- 9 funding for a certain stadium.
- 10 BY adding to

- 15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 16 MARYLAND, That the Laws of Maryland read as follows:

- 19 IN AND AFTER FISCAL YEAR 1997, THE DEPARTMENT MAY NOT EXPEND ANY
- 20 FUNDS FROM THE TRANSPORTATION TRUST FUND OR FROM ANY OTHER SOURCE
- 21 FOR THE CONSTRUCTION OF STATE OR COUNTY ROADWAYS OR FOR GRANTS
- 22 PERTAINING TO THE INFRASTRUCTURE REQUIRED AS A RESULT OF THE PROPOSED
- 23 REDSKINS STADIUM ON THE WILSON FARM PROPERTY IN PRINCE GEORGE'S
- 24 COUNTY UNLESS THE DEPARTMENT NOTIFIES THE SENATE BUDGET AND TAXATION
- $25\,$ COMMITTEE AND THE HOUSE APPROPRIATIONS COMMITTEE OF THE GENERAL
- 26 ASSEMBLY IN WRITING THAT THE DEPARTMENT, BEFORE THE SCHEDULED
- 27 OPENING OF THE STADIUM, WILL CONSTRUCT:
- 28 (1) A ROAD RAMP EAST OF THE INTERSTATE 95/495 CAPITAL BELTWAY
- 29 EXTENDING SOUTH FROM ARENA DRIVE IN PRINCE GEORGE'S COUNTY TO THE
- 30 INTERSTATE 495 BELTWAY, WHICH IS DESIGNATED AS RAMP C IN THE ALTERNATIVE
- 31 3 PLAN, FIGURE IV-3 (JUNE 1996); AND

- 1 (2) A ROAD RAMP EAST OF THE INTERSTATE 95/495 CAPITAL BELTWAY 2 EXTENDING NORTH FROM ARENA DRIVE IN PRINCE GEORGE'S COUNTY TO THE 3 INTERSTATE 495 BELTWAY, WHICH IS DESIGNATED AS RAMP D IN THE ALTERNATIVE
- 5 INTERSTATE 493 DELIWAT, WHICH IS DESIGNATED AS KAMP D'IN THE ALTERNA.
- 4 3 PLAN, FIGURE IV-3 (JUNE 1996).
- 5 SECTION 2. AND BE IT FURTHER ENACTED, That this Act is an emergency
- 6 measure, is necessary for the immediate preservation of the public health and safety, has
- 7 been passed by a yea and nay vote supported by three-fifths of all the members elected to
- 8 each of the two Houses of the General Assembly, and shall take effect from the date it is
- 9 enacted.
