- 28 WHEREAS, The Motor Vehicle Administration (MVA) and its Medical Advisory
- 29 Board (MAB), after a comprehensive review of Maryland's current vision standards for

- 1 drivers' licenses, have determined that changes are necessary to modernize current
- 2 standards and eliminate inconsistencies in current law; and
- 3 WHEREAS, The MVA and its MAB have concluded that there is a significant
- 4 population with vision problems that could drive safely under specified restrictions, but
- 5 that population is ill-served by Maryland's current standards; and
- 6 WHEREAS, The State has a responsibility to assist this growing population in
- 7 maintaining the independence that the automobile allows in a manner that does not
- 8 jeopardize their safety or the safety of others on the highways; and
- 9 WHEREAS, The MVA has appointed a Workgroup for Modified Vision
- 10 Standards consisting of medical professionals, MVA staff, and citizens with an interest in
- 11 driver vision standards to study this issue, and the Workgroup has issued
- 12 recommendations for revised standards which are set forth in this Act to better meet this
- 13 population's needs; and
- WHEREAS, The success of the standards set forth in this Act, depends, in part,
- 15 on continued study by the MVA of drivers' experience over a reasonable period of time;
- 16 and
- 17 WHEREAS, This Act, a joint work product of the MVA, the MAB, and the
- 18 Workgroup for Modified Vision Standards, is intended to accomplish these goals; now,
