4 FOR the purpose of requiring the Motor Vehicle Administration to establish an incentive

- 6 enforcement action against certain improperly registered motor vehicles; requiring
- 7 rewards under the incentive program to be paid to the local government employing
- 8 a law enforcement officer who issues a citation for an improperly registered motor

# 23 (A) IN THIS SECTION, "IMPROPERLY REGISTERED MOTOR VEHICLE" MEANS A24 MOTOR VEHICLE THAT:

25 (1) IS OWNED BY A PERSON WHO RESIDES IN THE STATE; BUT

26 (2) IS REGISTERED IN ANOTHER STATE.

(B) THE ADMINISTRATION SHALL ESTABLISH AN INCENTIVE PROGRAM
OFFERING FINANCIAL REWARDS IN ACCORDANCE WITH SUBSECTION (C) OF THIS
SECTION FOR THE PURPOSE OF ENCOURAGING LAW ENFORCEMENT OFFICERS TO

3 (C) (1) IF A LAW ENFORCEMENT OFFICER ISSUES A CITATION FOR AN

8 50% OF ANY EXCISE TAX COLLECTED BY THE ADMINISTRATION IN REGISTERING
