A BILL ENTITLED

1 AN ACT concerning

2 **Creation of a State Debt - Prince George's County - Town of Bladensburg - Bostwick**  
3 **House**

4 FOR the purpose of authorizing the creation of a State Debt not to exceed \$650,000, the  
5 proceeds to be used as a grant to the Mayor and Town Council of the Town of  
6 Bladensburg for certain acquisition, development, or improvement purposes;  
7 providing for disbursement of the loan proceeds, subject to a requirement that the  
8 grantee provide and expend a matching fund; requiring the grantee to grant and  
9 convey a certain historic easement; and providing generally for the issuance and sale  
10 of bonds evidencing the loan.

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
12 MARYLAND, That:

13 (1) The Board of Public Works may borrow money and incur indebtedness on  
14 behalf of the State of Maryland through a State loan to be known as the Prince George's  
15 County - Town of Bladensburg - Bostwick House Loan of 1997 in a total principal  
16 amount equal to the lesser of (i) \$650,000 or (ii) the amount of the matching fund  
17 provided in accordance with Section 1(5) below. This loan shall be evidenced by the  
18 issuance, sale, and delivery of State general obligation bonds authorized by a resolution of  
19 the Board of Public Works and issued, sold, and delivered in accordance with §§ 8-117  
20 through 8-124 of the State Finance and Procurement Article and Article 31, § 22 of the  
21 Code.

22 (2) The bonds to evidence this loan or installments of this loan may be sold as a  
23 single issue or may be consolidated and sold as part of a single issue of bonds under §  
24 8-122 of the State Finance and Procurement Article.

25 (3) The cash proceeds of the sale of the bonds shall be paid to the Treasurer and  
26 first shall be applied to the payment of the expenses of issuing, selling, and delivering the  
27 bonds, unless funds for this purpose are otherwise provided, and then shall be credited on  
28 the books of the Comptroller and expended, on approval by the Board of Public Works,  
29 for the following public purposes, including any applicable architects' and engineers' fees:  
30 as a grant to the Mayor and Town Council of the Town of Bladensburg (known as the  
31 Town of Bladensburg and referred to hereafter in this Act as "the grantee") for the  
32 acquisition, planning, design, repair, renovation, restoration, reconstruction, construction,  
33 and equipping of the historic Bostwick House, to be used for historic preservation and  
34 cultural programs.

1 (4) An annual State tax is imposed on all assessable property in the State in rate  
2 and amount sufficient to pay the principal of and interest on the bonds, as and when due  
3 and until paid in full. The principal shall be discharged within 15 years after the date of  
4 issuance of the bonds.

5 (5) Prior to the payment of any funds under the provisions of this Act for the  
6 purposes set forth in Section 1(3) above, the grantee shall provide and expend a matching  
7 fund. No part of the grantee's matching fund may be provided, either directly or  
8 indirectly, from funds of the State, whether appropriated or unappropriated. The fund  
9 may consist of real property, in kind contributions, or funds expended prior to the  
10 effective date of this Act. In case of any dispute as to the amount of the matching fund or  
11 what money or assets may qualify as matching funds, the Board of Public Works shall  
12 determine the matter and the Board's decision is final. The grantee has until June 1,  
13 1999, to present evidence satisfactory to the Board of Public Works that a matching fund  
14 will be provided. If satisfactory evidence is presented, the Board shall certify this fact and  
15 the amount of the matching fund to the State Treasurer, and the proceeds of the loan  
16 equal to the amount of the matching fund shall be expended for the purposes provided in  
17 this Act. Any amount of the loan in excess of the amount of the matching fund certified  
18 by the Board of Public Works shall be canceled and be of no further effect.

19 (6) (a) Prior to the issuance of the bonds, the grantee shall grant and convey to  
20 the Maryland Historical Trust a perpetual preservation easement to the extent of its  
21 interest:

22 (i) On the land or such portion of the land acceptable to the Trust;  
23 and

24 (ii) On the exterior and interior, where appropriate, of the historic  
25 structures.

26 (b) The easement must be in form and substance acceptable to the Trust  
27 and the extent of the interest to be encumbered must be acceptable to the Trust.

28 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
29 June 1, 1997.
