1 AN ACT concerning

2 State Retirement and Pension System - Board of Trustees - Divestiture of Assets

3 FOR the purpose of requiring the Board of Trustees for the State Retirement and

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

13 MARYLAND, That the Laws of Maryland read as follows:

14 Article - State Personnel and Pensions

15 21-123.

16 (c) (1) (i) Subject to [subparagraph] SUBPARAGRAPHS (ii) AND (III) of this 17 paragraph, the Board of Trustees may invest assets of the several systems subject to the 18 conditions that it imposes.

(ii) Not more than 25% of the assets that the Board of Trustees investsin common stocks may be invested in nondividend paying common stocks.

(III) THE BOARD OF TRUSTEES MAY NOT INVEST ASSETS IN ANY
COMPANY THAT, DIRECTLY OR INDIRECTLY, WRITES, RECORDS, PRODUCES,
ADVERTISES, MARKETS, SELLS, OR OTHERWISE PROMOTES ANY SONG, LYRICS, OR
OTHER MUSICAL WORK THAT:

251. ADVOCATES, GLAMORIZES, OR EXPLICITLY DESCRIBES26 ACTS:

A. OF VIOLENCE, INCLUDING MURDER, RAPE, SEXUALASSAULT, ROBBERY, BATTERY, AND ASSAULT;

B. OF SEXUAL DEVIANCE, INCLUDING ACTS OF 1 2 NECROPHILIA, PEDOPHILIA, AND BESTIALITY; C. OF ILLICIT DRUG OR ALCOHOL ABUSE; 3 4 D. OF VIOLENCE AGAINST LAW ENFORCEMENT OFFICERS; 5 OR 6 E. ASSOCIATED WITH GANG ACTIVITY OR CRIMINAL 7 BEHAVIOR; 8 2. DEGRADES, DENIGRATES, OR DEMORALIZES FEMALES; 9 OR 3. INCITES VIOLENCE AGAINST MEMBERS OF A 10 11 PARTICULAR SEX, RACE, OR ETHNICITY.
