- 12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 13 MARYLAND, That the Laws of Maryland read as follows:

- 16 (A) [Whenever] IF a local legislative body [shall have] HAS adopted the
- 17 transportation element of the plan of the territory within its subdivision jurisdiction or
- 18 part [thereof] OF THE TERRITORY, and [shall have] HAS filed a certified copy of
- 19 [such] THAT plan in the office of clerk of the circuit court of the county in which [such]
- 20 THE territory or part is [located:
- 21 (1) A] LOCATED, A plat of a subdivision of land within [such] THE
- 22 territory or part may not be filed or recorded until it [shall have] HAS been approved by
- 23 the planning commission and [such] THE approval entered in writing on the plat by the
- 24 chairman or secretary of the [commission; and] COMMISSION.
- 25 (B) [(2) If a plat of a subdivision of land within the territory or part contains 5 or
- 26 less lots, sites, or other divisions of land, the THE planning commission may authorize
- 27 [the chairman of the planning commission, ] the zoning administrator[,] or an
- 28 equivalent administrative official to approve [the plat of the] subdivision PLATS AND
- 29 SITE PLANS UNDER SUBSECTION (A) OF THIS SECTION IN ACCORDANCE WITH
- 30 NONDISCRETIONARY CRITERIA ADOPTED AND SPECIFIED BY ORDINANCE. The
- 31 approval shall be entered in writing on the plat.

1 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect

2 October 1, 1997.
