A BILL ENTITLED

1 AN ACT concerning

Creation of a State Debt - Montgomery County Agricultural Center 2

- 3 FOR the purpose of authorizing the creation of a State Debt not to exceed \$495,000, the
- 4 proceeds to be used as a grant to the Board of Directors of the Montgomery County
- 5 Agricultural Center, Inc. for certain development or improvement purposes;
- providing for disbursement of the loan proceeds, subject to a requirement that the 6
- 7 grantee provide and expend a matching fund; and providing generally for the
- issuance and sale of bonds evidencing the loan. 8

9 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 10 MARYLAND, That:

- 11 (1) The Board of Public Works may borrow money and incur indebtedness on
- 12 behalf of the State of Maryland through a State loan to be known as the Montgomery
- County Agricultural Center Loan of 1997 in a total principal amount equal to the lesser
- 14 of (i) \$495,000 or (ii) the amount of the matching fund provided in accordance with
- 15 Section 1(5) below. This loan shall be evidenced by the issuance, sale, and delivery of
- 16 State general obligation bonds authorized by a resolution of the Board of Public Works
- 17 and issued, sold, and delivered in accordance with §§ 8-117 through 8-124 of the State
- 18 Finance and Procurement Article and Article 31, § 22 of the Code.
- 19 (2) The bonds to evidence this loan or installments of this loan may be sold as a
- 20 single issue or may be consolidated and sold as part of a single issue of bonds under §
- 21 8-122 of the State Finance and Procurement Article.
- 22 (3) The cash proceeds of the sale of the bonds shall be paid to the Treasurer and
- 23 first shall be applied to the payment of the expenses of issuing, selling, and delivering the
- 24 bonds, unless funds for this purpose are otherwise provided, and then shall be credited on
- 25 the books of the Comptroller and expended, on approval by the Board of Public Works,
- 26 for the following public purposes, including any applicable architects' and engineers' fees:
- 27 as a grant to Board of Directors of the Montgomery County Agricultural Center, Inc.
- 28 (referred to hereafter in this Act as "the grantee") for the repair and renovation of, and
- 29 for the provision of capital equipment for an existing building, including infrastructure
- 30 upgrades, and for the planning, design, and construction of the Montgomery County
- 31 Agricultural, Business, and Education Center on the grounds of the Agricultural Center
- 32 in Gaithersburg.

- 1 (4) An annual State tax is imposed on all assessable property in the State in rate 2 and amount sufficient to pay the principal of and interest on the bonds, as and when due 3 and until paid in full. The principal shall be discharged within 15 years after the date of 4 issuance of the bonds.
- 5 (5) Prior to the payment of any funds under the provisions of this Act for the 6 purposes set forth in Section 1(3) above, the grantee shall provide and expend a matching 7 fund. Of the total matching fund, the County Executive and County Council of 8 Montgomery County pledge \$247,500 and the grantee pledges \$247,500. The grantee, 9 however, is responsible for the provision of the matching fund. No part of the grantee's
- 10 matching fund may be provided, either directly or indirectly, from funds of the State,
- 11 whether appropriated or unappropriated. No part of the fund may consist of real
- 12 property, in kind contributions, or funds expended prior to the effective date of this Act.
- 13 In case of any dispute as to the amount of the matching fund or what money or assets may
- 14 qualify as matching funds, the Board of Public Works shall determine the matter and the
- 15 Board's decision is final. The grantee has until June 1, 1999, to present evidence
- 16 satisfactory to the Board of Public Works that a matching fund will be provided. If
- 17 satisfactory evidence is presented, the Board shall certify this fact and the amount of the
- 18 matching fund to the State Treasurer, and the proceeds of the loan equal to the amount
- 19 of the matching fund shall be expended for the purposes provided in this Act. Any
- 20 amount of the loan in excess of the amount of the matching fund certified by the Board
- 21 of Public Works shall be canceled and be of no further effect.
- 22 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 23 June 1, 1997.
